Narrative:

On October 14, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Chuck Moran (Moran) continued reviewing body-worn camera (BWC) video files for this case.

SAS Moran located two BWC video files on the SIU shared drive for Ashtabula County Sheriff's Office (ACSO) Sergeant Sterrick. They were labeled:

- 1. Sterrick 1 of 2
- 2. Sterrick 2 of 2

SAS Moran made working copies of each video and placed them in a folder on his BCI-issued laptop. The working copies of the videos were used for the review.

SAS Moran imported the videos into Amped Replay for review.

Review of Video File Labeled, "Sterrick 1 of 2"

SAS Moran reviewed the video file labeled, "Sterrick 1 of 2" first. SAS Moran noted the following information:

- The video-embedded timestamp date was 2024-05-31.
- The video-embedded timestamp start time was 18:34:58.
- The video-embedded timestamp end time was 18:55:34.
- The video file was an Axon brand BWC.
- The BWC was affixed to ACSO Sergeant Sterrick.
