#### Narrative:

On Thursday, April 4, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) along with SA Bill Conn (Conn) conducted a neighborhood canvass in the area of 8<sup>th</sup> Street NE and High Avenue in the City of New Philadelphia for available video surveillance footage. The videos are in reference to the Officer Involved Shooting that occurred on 8<sup>th</sup> Street.

The initial scene started in the 100 block of 8th Street NE and concluded on Tell Street NE at East High Avenue. Initially, a list of residents with cameras was created by the New Philadelphia Police Department (NPPD). After obtaining this list, agents conducted a drive through the area to confirm the findings and locations to determine the relevancy of the cameras.

After a check of the area, the following are the residents with camera footage deemed relevant to the OIS investigation:

#### Cindy Abel - 202 8th Street, new Philadelphia, Ohio

At 1105 hours, SA Goudy and Conn spoke with the resident Cindy Abel (Abel). She stated that the cameras on her residence are live feed only. However, Abel stated that she had video recorded on her cell phone camera of the incident. The first image depicts still images from google maps to show the relation of where Abel's residence was to where Matthew Flynn (Flynn) drove a Ford Raptor pickup truck into another residence.

This video was taken just before the officer involved shooting incident occurred and ended just before. The duration of the video was 0:00:32 seconds.

This photo depicts the view from Abel's residence of the truck driven by Flynn after it crashed into the residence across the street.

At the 0:00:11 mark of the video, the TCSO deputy is heard yelling, "get out of my car, get out of my car!" multiple times off in the distance.



After multiple times of yelling, "get out of my car!" was heard, Abel walked closer and aimed her cell phone camera down 8th Street NE.

At the 0:00:28 mark of the video, the overhead blue lights of the Tuscarawas County Sheriff's Office (TCSO) patrol vehicle were observed down 8th Street NE, approximately halfway down the block. During this time, the deputy was still heard yelling, "get out of my car!" multiple times.

#### Anna Fisher - 114 8th Street NE, New Philadelphia, Ohio

At 1050 hours, SA Goudy and Conn spoke with Anna Fisher (Fisher). Fisher stated she had a "Nest" camera system which contained two cameras on the exterior. One camera was positioned on the front porch of the residence facing East. The second camera was positioned above the front door facing south towards 8th Street.

The duration of the video was 19 seconds

At the start of the video, screeching tires could be heard off in the distance followed by Flynn crashing into the residence located at 145 8th Street NE. Immediately after the collision was heard, the revving of an engine was also heard. Nothing further to report from this video file.

At the 00:10 mark of the video, the TCSO unit arrived on scene with the overhead emergency lights activated. When the TCSO unit arrived, someone is heard yelling, "wait, there he is."

At the 00:15 mark of the video, as the TCSO unit came to a stop, someone ran in front of the headlights of the TCSO unit. When the deputy exited his vehicle, he began to chase the individual, later identified as Flynn. As the deputy ran around the front of the TCSO unit, Flynn entered the vehicle at the driver's side. The deputy was then heard yelling, "get out of my car" multiple times. The deputy was also heard yelling, "I will shoot you." During this time, while Flynn was in the driver's seat of the TCSO unit, Flynn was heard yelling back saying, "It's me, It's me!" As the deputy was yelling at Flynn to get out of the vehicle, the engine of the TCSO unit was heard revving multiple times.






At the 00:01 mark of the video, three gunshots were heard being fired, followed by the TCSO unit driving away moments later with the overhead emergency lights and siren activated. Nothing further to report from this video file.

#### Bill Green - 125 8th Drive NE, New Philadelphia, Ohio

The surveillance video files received from resident Bill Green (Green) did not record the actual officer involved shooting incident. However, audio of the initial accident involving Flynn driving his truck into a house was heard, along with the three gunshots being fired. The video file from Green also recorded some of the aftermath of the shooting, including Flynn driving the stolen TCSO unit through his neighborhood.





At the 05:37 mark of the video, the sound of screeching tires is followed by a crashing sound, which was consistent with Flynn crashing his vehicle into a house. Soon thereafter, sirens are heard in the distance, getting louder as the TCSO vehicle driven by Flynn approached Miltenberger's residence.

Additional police and fire units arrived on-scene and assisted with securing Flynn along with administering emergency medical aid. Nothing further to report from this video file and resident.








