Narrative:

On May 23, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent Steven Seitzman (SA Seitzman) received Clermont County Communications 9-1-1 calls related to the initial dispatch to 947 SR-28 Business (Berry Lane Apartments). The records were provided to SA Seitzman by Miami Township Police Department (MTPD) Sergeant Josh Bail. On May 26, 2022, Sergeant Bale provided SA Seitzman with the Clermont County police radio traffic.

The initial 9-1-1 caller identified himself as Skylar Strahler, who was interviewed by BCI Special Agent Dave Hornyak on May 20, 2022. During the 9-1-1 call, Mr. Strahler advised that a female subject came outside and shot a gun in the air. The female subject told Mr. Strahler to call the cops. The dispatcher asked Mr. Strahler if the subject lived in the apartment complex, to which he answered in the affirmative. The dispatcher then asked Mr. Strahler what the subject was wearing. He said she was wearing "Nothing! Pants, I think. No bra, nothing." He advised the dispatcher that the subject was not wearing a shirt. During the call, Mr. Strahler said the first time the subject came out, she appeared to be looking for someone. He said she came out a second time and approached his vehicle. He told the dispatcher that the female subject said, "If you guys want to talk shit, blah, blah, blah, blah, blah," then fired her gun in the air. Mr. Strahler advised the dispatcher that the subject was coming at him with a gun again and disconnected the call.

The second caller was identified as Casey Greenberg, who was interviewed by SA Seitzman on May 20, 2022. He advised the dispatcher that the emergency was at the Berry Lane Apartments. He stated that he heard an audible gunshot. He stated the involved subject was Camille Weems (Ms. Weems), a resident of 947 SR-28 Business, Apartment 16. He advised that Ms. Weems asked him for help with a gun the day prior. While speaking with the dispatcher, he said Ms. Weems exited the building into the parking lot without a shirt. He then told the dispatcher the female had a gun and shot it again. He told the dispatcher, "This is active shooter." He then

said she fired it "like three times," then corrected himself and said "twice." He then said, "She's aiming it at the streets," followed by, "She's firing again." The sound of rapid gunfire is then heard at approximately three minutes and seven seconds into the call. Mr. Greenberg then said, "She's down." "Someone shot her." He said the cops were there and terminated the call.
