**Narrative:**

On September 23, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent Lauren Frazier (SA Frazier) was notified by the Montgomery County Coroners Office that the post-mortem examination of the decedent, Patrick Foley, would be conducted on the same date.

SA Frazier responded to the Montgomery County Coroners Office, located at 361 W. Third Street, in Dayton, Ohio 45402, to attend the post-mortem examination of Foley. Upon arrival, SA Frazier learned that the post-mortem examination was primarily completed. SA Frazier spoke to Dr. Donald Higgs, who performed the post-mortem examination.

Dr. Higgs stated that he has received Foley's medical records and reviewed the body worn camera video of the incident. He advised that the following observations were made during the course of the autopsy:

Dr. Higgs noted [REDACTED] Dr. Higgs advised that there was no evidence collected from Foley's body during the post-mortem examination. Therefore, nothing was received by SA Frazier regarding autopsy evidence.

On September 23, 2025, SA Frazier sent an email to Montgomery County Coroners Office Records Department requesting to receive a copy of the preliminary autopsy report (if applicable), autopsy photographs, final autopsy report, death certificate, and toxicology report, once available.
