Narrative:

On May 21, 2022, at approximately 1130 hours, Special Agent Kenneth Smith with the Ohio Bureau of Criminal Investigation (BCI) and Sergeant Josh Bail with the Miami Township Police Department responded to Range USA located at 10930 Deerfield Road, Cincinnati, Ohio. It was in regards to a firearm used in an Officer-Involved Critical Incident (OICI) that occurred at 947 Business State Route 28, Milford, Clermont County, Ohio, involving the Miami Township Police Department and Camille Weems. SA Smith spoke to the manager Ashton Rock about the sale of a Taurus firearm sold on May 16, 2022, to Camille Weems.

The interview was not recorded. Ms. Rock did provide SA Smith with the receipt and ATF form 4473 from the date of sale as well as the security video footage of Ms. Weems in the store on the date of purchase. Ms. Rock also advised that the sales person would be in later in the day for work and SA Smith stated that he would return to talk to him.
