This contract covers the construction and completion of contract for combined general, plumbing and electrical

work for a building known as the Carpenter Shop, Ohio Soldiers' and Sailors' Home, Sandusky, Ohio, as set forth in Item No. 1 of the Form of Proposal dated September 16, 1930. Said contract calls for an expenditure of seven thousand seven hundred and fifty dollars (\$7,750.00).

APPROVAL, LEASE TO DEPARTMENT OF AGRICULTURE FOR RIGHT TO USE AND OCCUPY FOR THE PURPOSE OF FISH PROPAGATION, MIAMI AND ERIE CANAL PROPERTY IN SHELBY COUNTY, OHIO.
