Narrative:

On Friday, January 05, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) received video footage originally obtained by BCI SA Al Bansky (Bansky). SA Bansky was informed that the videos contained footage from the body cameras recorded by the Canton Police Department (CPD).

SA Lieber reviewed the video recordings and noted the following:

This video is 14 minutes and 53 seconds in duration. The video is recorded by the body-worn camera (BWC) of Canton Police Department Officer (Ofc.) Allison Colecchi (Colecchi). The time stamp at the beginning of the video is 12/05/2023 at 22:08:27.

The video begins showing Colecchi seated inside of a building. Colecchi stands up, runs outside, and gets into a marked police vehicle. At 22:08:57, sound can now be heard. At 22:10:19, Colecchi begins to exit the vehicle. Colecchi runs into an apartment building and up a flight of stairs. Colecchi exits the building and runs toward the area where the shooting occurred. As Colecchi approaches the area, multiple officers are already on scene and aid is being provided to Zachary Fornash (Fornash). See screenshot below.

Colecchi assists with providing aid to Fornash. At 22:16:16, an ambulance arrives. At 22:18:03, Colecchi is assigned to stand by at the area where the shooting occurred for scene and evidence security. Colecchi maintains this position for the duration of the video recording. At 22:23:20, the video ends.
