**Narrative:**

On April 4, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) received an email from Trace Evidence Unit Supervisor Curtiss Jones of the Cuyahoga County Medical Examiner's Office (CCMEO). The email contained an attachment indicating that items of evidence were ready for pickup. The evidence items were obtained during the autopsy of Matthew Flynn.

On April 10, 2024, at 1207 hours, SA Lieber picked up the items of evidence from the CCMEO. The evidence consisted of:

CCMEO item #	Description
001	One adhesive stub for gunshot primer residue examination from the hands
002	One swab from under the fingernails of the right hand
003	One swab from under the fingernails of the left hand
004	Blood stain card
006	Buccal swabs from release
007	Projectile from left chest

Items 001, 002, 003, 004, and 006 were subsequently packaged together as BCI item #23. Item 23 was submitted to BCI Richfield main evidence on April 10, 2024, at 1320 hours.

Item 007 was subsequently packaged as BCI item #24. Item 24 was submitted to BCI Richfield temporary evidence locker #3 on April 10, 2024, at 1324 hours.

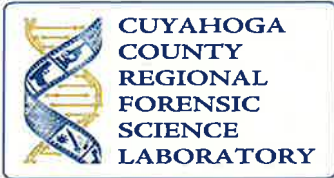


