**NARRATIVE**

**Menacing/Named Suspect**

Sir,

On Wednesday, July 6th 2022 at 1944 hours, while assigned to 5A21 in the company of P.O. Woznicki #2508 we responded to 1116 E67th St in connection with threats.

Upon our arrival we conferred with [REDACTED] (victim) who stated the following, her neighbor Robert Perkins (suspect) said out loud that he has enough ammo to blow up the entire street while she was in her backyard with her children and sister and Perkins was in his backyard. White felt that the threat was real because of previous situations they have had in the past so she called Police for help.

While conferring with Perkins he stated the following that he was listening to a recording on his loud speaker and that he did not say anything to White.
