**Narrative:**

On Monday, October 02, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Russell (SA Russell) received Jamie Overstreet's (Overstreet) medical records from Grant Medical . The records were obtained pursuant to a court order. SA Russell reviewed the medical records and noted the following:

Overstreet's medical records consisted of 33 pages. Overstreet arrived at Grant Medical Center, Columbus, Ohio at 2335 hours on August 23, 2023, [REDACTED] Overstreet was pronounced dead at 2342 hours on August 23, 2023, by Dr. Deshpande.



It is further ordered the Ohio Health does not notify any person of the existence of this order for 90 days.

**The failure to comply with this court-ordered Investigative Subpoena may result in a contempt of court citation.** However, you can comply with this Investigative Subpoena without the court appearance scheduled below by providing the requested information to the law enforcement officer who requested this subpoena, and whose contact information is set forth below, prior to the date scheduled for the appearance.
