On January 24, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chad Holcomb was interviewing Lawrence County Sheriff's Office (LCSO) [REDACTED] [REDACTED] [REDACTED] regarding his involvement in the officer involved shooting on January 9, 2024.

At the conclusion of the interview, [REDACTED] [REDACTED] produced a large stack of training certificates and firearm qualifications to SA Holcomb. SA Holcomb stated that he had already received firearm and training records from the LCSO. [REDACTED] [REDACTED] stated that there are additional certificates that LCSO didn't have.
