**Narrative:**

On Saturday, November 4, 2023 at approximately 0324 hours, the Ohio Bureau of Criminal Investigation (BCI) Crime Scene Unit (CSU) and Special Investigations Unit (SIU) responded to an officer-involved shooting which occurred in the area of 5230 Douglas Drive, North Olmsted, Ohio.

Special Agent (SA) Ed Staley (Staley) collected the physical items of evidence from the crime scene. SA Matt Armstrong (Armstrong) collected the involved officers' firearms, a body camera from the involved Westlake officer, pertinent evidence from the involved North Olmsted officer, and the involved subject's clothing collected at Cleveland Clinic Fairview Hospital by North Olmsted Officer Angel Walling.

At approximately 1147 hours, SA Staley met with SA Armstrong at the scene. The items of evidence collected from the crime scene were turned over to SA Armstrong who then transported them to the BCI Richfield office located at 4055 Highlander Parkway, Richfield, Summit County, Ohio 44286.

At approximately 1300 hours, SA Armstrong transported the all the collected evidence to the BCI Richfield Office. At approximately 1415 hours, the items were secured in BCI Temporary Evidence Locker #40 and the BCI Temporary Evidence Drying Room.
