Narrative:

On April 21, 2021, Ohio Bureau of Criminal Investigation (BCI) Special Agents Jim Mulford (SA Mulford) and Matthew Collins (SA Collins) conducted a neighborhood canvass of the area immediately surrounding the residence of 3171 Legion Lane, Columbus, OH.

The neighborhood canvass was conducted in response to an Officer Involved Critical Incident (OICI) incident that took place on April 20, 2021, involving the Columbus Division of Police (CPD) and Ma'Khia Bryant (Bryant). The following is a summary of those conversations.

3195 Legion Ln.

No answers at door. Agents left a business card. A doorbell camera was identified on the residence, but it appeared to not be trained on the incident location.

3189 Legion Ln.

Agents spoke with Gerry Slocum. (614-424-2448). She advised she was working from home at the time of the incident. She did not see the incident but heard four gunshots. Her 17 year old son, Cedric Slocum, advised he was asleep when the gunshots woke him.

3183 Legion Ln.

Agents spoke with Chris Mitchell. (614-290-7613). He was in the backyard when he heard four gunshots. By the time he came around to the front yard the incident was over. A doorbell camera was identified on the residence, but it appeared to not be trained on the incident location.

3174 Legion Ln.
