**Narrative:**

On Wednesday, October 15, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joe Lamping (SA Lamping) received documents from Captain John Elberty of the Trumbull County Sheriff's Office (TCSO). The records which were requested included any reports pertaining to the October 12, 2025, officer-involved critical incident, except for any statements made by the involved officers. SA Lamping reviewed the documents and noted the following:

The report completed by TCSO Deputy James Lewis (Dep. Lewis) is 25 pages in length and consisted of the incident report, witness statements from family members involved in the initial incident, and photographs.

The report listed the incident location as 7123 Oakfield North Road Northwest, Bristol Township, Ohio. The date and time of the incident was listed as October 12, 2025 at 0609 hours. One offense was listed in the report: Domestic Violence ORC 2925.19. Sarah Bailey (Sarah) was listed as the victim of the offense and Brad Bailey (Brad) was listed as the suspect. One vehicle, a 2012 white Buick, was also listed on the report.

Dep. Lewis described the incident over three pages in the narrative. He reported that he was sent to a "disturbance" in which the dispatcher was able to hear yelling on the other end of the line. He advised that the dispatcher reported that it, "*sounded as if the female was being assaulted,*" prior to the caller hanging up the phone. Dep. Lewis wrote:

*Dispatch stated Sarah explained Brad broke in through a window assaulted her and her sister and choked her. Dispatch advised Sarah told them Brad said he was going to die today and possibly was in possession of two guns. Dispatch later advised Brad left in a white Buick and left towards State Route 45. (Page 2)*

Dep. Lewis checked the area for Brad and waited until [REDACTED] arrived on scene to respond to the residence. Once the deputies arrived at the residence they met with Sarah, Sarah' daughter, and Sarah's sister, Albri Lafferty (Lafferty). Dep. Lewis reported the following recounting of the events:

NARRATIVE

Upon arrival I confirmed the white Buick was gone from the residence. Since the caller was on the phone with dispatch I continued to patrol the area for Brad in the white Buick. I patrolled the immediate area and once [REDACTED] was close I returned to the residence to speak with Sarah. I met Sarah, her daughter L.P and her sister Albri Lafferty on the front porch of the residence. I asked Sarah what happened, she stated she was sleeping and was awoken by Brad breaking into the bedroom window. Sarah said she got up and ran to the house phone as he was running after her. Sarah said she ran outside to get into her white Buick in the driveway and Brad chased after her. Sarah said Brad was yelling "were all going to die today". Sarah said she tried to get into the Buick but it was locked. Sarah said Brad caught up to her grabbed her by the throat and lifted her up off the ground. Sarah said Brad was yelling "you fucking whore you fuck everyone were going to die". Sarah said she was screaming and fighting against Brad to get away. Sarah said Brad slammed her onto the back of the Buick and then slammed her onto the ground.

Sarah explained L.P. heard the fighting and came out of the house to see what was going on. Sarah said Brad then went after L.P., chasing her into the residence. Sarah said as she came back into the house she noticed Brad taking the phone from L.P. Sarah said her sister Albri Lafferty came out of her room to see what was going on and Brad went after her as well. Sarah explained Brad took Albri's phone then began pushing and striking her. Sarah said Albri got onto the ground and covered her head and face with her arms. Sarah said L.P. was able to get a phone and called 911. Sarah stated she also called 911 and was trying to leave but did not want to leave without L.P. and went back inside for her. Sarah said she left the Buick running in the driveway when she went back inside and Brad came out and drove off in it with what she believed to be two handguns.

I then spoke with L.P., she explained she heard Sarah yell and thought she was yelling at the dogs. L.P. said she realized Sarah was screaming for help so she got up and ran outside to the noise. L.P. said when she got outside she saw Brad assaulting Sarah while she was screaming for help. L.P. said Sarah told her to call 911, Brad turned around and ran after her. L.P. said she ran into the house and Brad caught up to her, began throwing her around and wrestling for her cell phone. L.P. said Brad told her "Stop I dont want to hurt you". L.P. said Brad threatened to kill all of them.

I also asked Albri what happened, she explained she was in her bedroom and Brad kicked the door in. Albri said the door was locked. Albri said Brad lunged for her cell phone and took off with it. Albri said she ran after Brad into the living room to see Brad physically fighting with Sarah. Albri said she tried to get in between the two of them and Brad pushed her down. Albri said when she fell she struck her head on something. Albri said she began kicking Brad to try and get him off and he punched her in the right eye. Albri said Brad grabbed both her and Sarah. Albri said Brad was pulling Sarah's hair and shoved her forward, causing her to fall. Albri said Brad left the residence and came back in through the window swinging a gun around. Albri said she and Sarah ran out to get into the Buick but were waiting on L.P. to get out there and Brad took the car.

Dep. Lewis continued on to explain that he obtained written statements from the three individuals at the residence as well as photographs of the injuries they sustained. He also requested that a Champion Township Police Department (CPD) unit located Brad and the vehicle he left in. Dep. Lewis was eventually able to make phone contact with

Brad. The first time Brad answered the phone, he hung up on Dep. Lewis. On the second call Dep. Lewis reported the following:

*I then called Brad a second time and advised him to pull the car over and speak with the officers. Brad said "fuck you" then asked to speak with Sarah. I advised him he was not speaking with Sarah and he needed to pull over. Brad told me he was going to get out with his guns and was going to die. Brad then hung up on me.*

Dep. Lewis reported that he left the Bailey residence when he heard that the vehicle had been stopped and a male was running away with a gun. In the final paragraph of the narrative Dep. Lewis explained that charges that were being pursued against Brad:

Domestic Violence O.R.C. 2919.25 M-1 x 3, Strangulation O.R.C. 2903.18 F-4 charges will be pursued against Brad through Newton Falls Municipal Court. Brad was previously arrested for domestic violence but plead to a lesser offense through newton Falls Municipal Court.

Also included in Dep. Lewis' report were the written statements completed by the individuals on scene as well the photographs of their injuries. The only written statement clearly legible was Sarah's. It recounted the same version of events as documented in Dep. Lewis' narrative.

The photographs taken by Dep. Lewis showed what he described as "minor injuries" to Sarah and Lafferty.

I asked all three woman to fill out a voluntary written statement, in which they all did. I collected the statement forms and went over the victim of rights form with them. I photographed Sarah's neck, I was able to see some scratched where skin was hanging and some redness. I also photographed Sarah's right leg below her knee, she had a bruise from being thrown down. I photographed Albri's Face, I did not see much trauma at this time. I advised them if it got worse to call as swelling may occur later due to it being so fresh.

While standing at the residence I was able to hear a Champion Unit locate the white Buick Brad was in. A be on the look out was put out as he was suicidal and potentially armed [REDACTED] ordered a ping on the cell phone due to the nature as well. While listening to the pursuit I attempted to call Brad on the phone to attempt in getting him to pull over. I spoke to Brad twice, the first time I advised Brad who I was and he hung up on me. I then called Brad a second

time and advised him to pull the car over and speak with the officers. Brad said "fuck you" then asked to speak with Sarah. I advised him he was not speaking with Sarah and he needed to pull over. Brad told me he was going to get out with his guns and was going to die. Brad then hung up on me. I completed collecting information with Sarah, L.P. and Albr. I advised Sarah someone would contact her if and when Brad is arrested.

I left the residence after I overheard the vehicle stopped, the driver got out running with a gun and there were shots fired . All paperwork will be copied into the report and the originals will be filed in the Trumbull County Sheriff's Office. The photos that were taken will also be put into this report for review.
