Narrative:

On Tuesday, September 10, 2024, at approximately 1010 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent John Tingley (Tingley) transported items of evidentiary value to BCI-Richfield Regional Office from 1370 Belmont Avenue, Youngstown, Mahoning County, Ohio, 44504.

At 2155 hours, SA Tingley received sixteen (16) items of evidence collected from 1370 Belmont Avenue, Youngstown, Ohio, by BCI Crime Scene SA Chad Doran and SA Larry Hootman.

SA Tingley then transported the 16 items evidence to the Richfield Northeast Regional Office, arriving at approximately 2310 hours. The evidence was then placed into BCI Richfield Temporary Evidence Locker #1. Copies of the evidence receipt from the incident scene were placed in the locker with the evidence items.
