Narrative:

On Tuesday, June 07, 2022, at approximately 2010 hours, the Ohio Bureau of Criminal Investigation (BCI) was requested by Sgt. Billy Duffer of the Franklin County Sheriff's Office (FCSO) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved shooting which occurred in the area of 2280 Stelzer Road, Columbus OH, 43215. BCI Special Agent John Butterworth (SA Butterworth) responded to assist, arriving at approximately 2210 hours. Also responding from the BCI Special Investigations Unit were Special Agents Matt Collins, David Wieging, and Todd Fortner. Additionally, the BCI Crime Scene Unit was requested to process the scene by documenting and collecting pertinent evidence.

The shooting incident involved a subject, Pozz Adrian Striblin, and members of the Franklin County Sheriff's Office. The incident resulted in the death of Striblin.

Special Agent Butterworth,

Last evening around 7:00pm, deputies from the Franklin County Sheriff's Office were executing a warrant arrest on an individual identified as Pozz Adrian Striblin. The warrant was issued through the Franklin County Municipal Court for an F-3 Failure to Verify Address. Deputies followed Mr. Striblin to the lot of the Sunoco at 2280 Stelzer Rd. There a confrontation ensued and gun shots were fired causing the death of Mr. Striblin. None of the deputies suffered significant injuries as a result.

After consultation with Sheriff Dallas Baldwin, it was decided to request the assistance of Ohio BCI as the lead investigative agency. We appreciate you and your staff's help, and please let this written correspondence serve as said official request to do so.
