Narrative:

From July 27, 2023 to August 25, 2023, Bureau of Criminal Investigation (BCI) Special Agent Kyle Douglass (SA Douglass) received copies of Alcohol, Tobacco, Firearms, and Explosives (ATF) Firearms eTrace Reports. These reports were completed by ATF following and Officer-Involved Critical Incident (OICI) which occurred on June 15, 2023 at 428 Foster Avenue in Cambridge, OH. It was learned Cambridge Police Department (CPD) officers were responding to a domestic disturbance involving Taurean Brown (Brown). During the encounter, Brown allegedly discharged a firearm at responding officers and a CPD SWAT officer returned fire with his duty weapon. A police drone was sent into the residence and Brown was discovered in the upstairs hallway deceased, with an apparent self-inflicted gunshot wound and several firearms in his vicinity. BCI Crime Scene Unit (CSU) agents recovered numerous firearms from the scene of the incident which reportedly did not belong to any law enforcement officers on scene.

SA Douglass reviewed all ATF eTrace reports received for firearms recovered from the aforementioned incident.
