Narrative:

On November 14, 2024, Special Agent (SA) Josh Rammel (Rammel) of the Ohio Bureau of Criminal Investigation (BCI) completed the review of all social media information provided by the Findlay Police Department (FPD) regarding the Officer Involved Critical Incident (OICI) that took place at 1105 Bernard Avenue, Findlay, Ohio on October 28, 2024.

The social media information provided was divided into two categories: general social media posts regarding the OICI and the social media accounts regarding the involved juvenile Kalvin Darapheth (Kalvin).

- 1. SA Rammel observed the following information contained in the general social media posts.
- A. The majority of posts from unrelated individuals contained arguments about what actually occurred during the OICI including unfounded rumors that another juvenile shot at police instead of Kalvin, and that Kalvin actually pulled out his phone as the police shot him. Some of the rumors subsided as the time-distance from the OICI passed.
- B. There were multiple posts where unrelated individuals were commenting that Kalvin's aunt was telling everyone that Kalvin did not have a gun, nor did Kalvin have any alcohol.
- C. There were several posts talking about Kalvin's memorial and information regarding a Go Fund Me page created for Kalvin's family.
- D. There were multiple mentions of a doorbell camera catching the gun shots on audio. The response to this was negative criticism of the FPD for firing multiple times at Kalvin as Kalvin ran away. A recording of the pertinent doorbell camera was attached with the social media information. SA Rammel discussed the doorbell camera footage with SA Tiffany Najmulski (Najmulski). SA Najmulski advised that she already reviewed the doorbell footage and was addressing it in a separate Investigative Report (IR).
- E. The only general social media post that was deemed important to the investigation was a

Facebook post from username "Jodi Lynn (Jodi)". Jodi commented to username "Jennifer Elliot Butler (Butler)" "we are good. Never seen anything like that before. Sat on my couch and see the whole thing". See IR 17, authored by SA Rammel, for the follow up interview with Jodi.

- 2. SA Rammel observed the following information from the social media accounts identified as belonging to Kalvin.
- A. SA Rammel identified and reviewed Facebook account information from username "Kalvin Daraphet". Multiple images observed on the title page of the account clearly identifying the account as belonging to Kalvin. The Instagram account "azvin_music" was attached to the account. An image of Kalvin and another unidentified individual defacing a pillar to a building was observed, during which Kalvin was drinking an unknown pink bottle that appeared to be alcohol.
- B. SA Rammel reviewed all Instagram accounts belonging to Kalvin.
- a. Instagram account "azvin_music" was set to private but was attached to YouTube account "AZVin27".
- b. Instagram account "Kalvin419567" appears to be an older account due to Kalvin appearing young. An image of a black handgun with serial number "JO41833" was posted on the account. The handgun was identified as a Grand Power G9 with the number "9P.A. Knall" visible on the side of the handgun. A Grand Power G9 with the designation "9P.A. Knall" indicates that gun is a non-lethal gas pistol noise making gun.
- c. Instagram account "watermelonslice.1" identified Kalvin as the operator of the account. No additional important details were observed in the attached images.
- C. TikTok account "kalvindarapheth" was reviewed. No information was observed, and no images clearly identifying the account as belonging to Kalvin were observed.
- D. YouTube account "Azvin27" utilizing screen name "AZvin" was reviewed by SA Rammel. The image of the account appears to be Kalvin holding up a potential gang sign. Multiple songs performed by Kalvin and additional individuals were posted on this account. All of the songs contain multiple racial slurs, threats of physical violence against other individuals, threats of violence specifically to "niggers, bitches, and snitches", multiple mentions that the rapper of the song carries a "pole" and knives, and one song dedicated to the rapper being a member of the Crip gang. Per the contents of the songs the term "pole" refers to a gun.

In a press release Tuesday morning, Findlay police said the juvenile shot in the incident had died. Police have not released the name or age of the juvenile, but Kalvin's family told WTOL 11 it was him.

Lena said Kalvin's death still doesn't "feel like it's real" and that "it hasn't sunk in."

A Findlay resident provided WTOL 11 with home security camera footage they say captured the sound of multiple gunshots from the incident. The footage does not show the actual shooting, though.

It is unclear at this time how many times Kalvin or the police officer, who has not been identified, fired shots. Lena says the amount of gunshots heard was excessive, though, and she believes Kalvin did not have a gun.

"One is enough on his leg," she said. "You don't need to kill him. This is not a war."

Philip Stinson, a criminal justice professor at Bowling Green State University who studies police misconduct, said more information needs to come out before anyone can make judgments.

The Findlay Police Department said in a press release on Tuesday it is working with the Ohio BCI and the Hancock County Prosecutor's Office "on releasing redacted information in the near future regarding Axon Body Worn Camera footage."

"Sometimes the initial statements made by officers, the reports that are written by officers involved in these incidents, turn out to be inaccurate. Sometimes the statements and reports are factually inconsistent with the video evidence," Stinson said.

The body camera footage is exactly what Lena says Kalvin's family wants to see.

"We want to see the body cam," she said. "(To see) if he had a gun."

Findlay Police Chief James Mathias said Wednesday that two patrol officers are on "paid critical incident leave status" as a result of the incident.


An autopsy conducted by the Lucas County Coroner's Office said Darapheth died from multiple gunshot wounds and his death has been ruled a homicide.


