Narrative:

On October 20, 2023, at about 1423 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) spoke with Karen Fisher (Fisher) by phone. Fisher had previously called and left a voicemail on SA Moran's desk phone. Fisher said that her mother was Delaine Koelliker (Koelliker) and that there was an incident near Koelliker's house on October 3, 2023. Fisher said her sister, Linda Schall (Schall), watched some of the incident through home surveillance cameras that were installed at Koelliker's house. Fisher said Schall heard the police yelling and the gunshots while watching the live feed.

Fisher said Koelliker has "dementia" and that is why the home surveillance cameras were installed. Fisher told SA Moran that there were two video recordings saved. One video recording showed the officers behind Koelliker's house and the other video recording was from inside the house and it captured the sound of the gunshots that were fired. Neither recording showed the shooting incident. Fisher said the home surveillance system brand was YI Technology with Kami model cameras.

Fisher explained that the interior camera did not record the shooting incident other than the sound of the gunshots at about 2229 hours. She said the exterior camera faced the backyard and did not record the shooting incident either. Fisher also told SA Moran that Koelliker does not know that the cameras are at her house.

SA Moran asked Fisher about her YI Technology account details. Fisher said she checked her cloud storage, but it only holds video recordings for 15 days. Fisher said she saved a short video recording of the officers behind her mother's house. She was not certain if Schall or her brother-in-law, Robert Patrick (Patrick), saved the video recording of the sounds recorded inside Koelliker's residence.

The phone call with Fisher was audio recorded. The audio recording was uploaded to Evidence.com. It was also uploaded to Matrix. The audio recording was attached to this report.

Dear Sir or Madam:

I am writing to make a formal request for the preservation of records and other evidence pursuant to 18 U.S.C. § 2703(f) pending further legal process.

You are hereby requested to preserve, for a period of 90 days, the records described below currently in your possession, including records stored on backup media, in a form that includes the complete record. You also are requested not to disclose the existence of this request to the subscriber or any other person, other than as necessary to comply with this request. If compliance with this request may result in a permanent or temporary termination of service to the accounts described below, or otherwise alert the subscriber or user of these accounts as to your actions to preserve the referenced files and records, please contact me before taking such actions.

This request applies only retrospectively beginning **Tuesday, October 3, 2023 at 1200 hours (12:00pm) Eastern Standard Time through Wednesday, October 4, 2023 1200 hours (12:00pm) Eastern Standard Time.** It does not in anyway obligate you to capture and preserve new information that arises after the date of this request.
