**Narrative:**

On Thursday, March 30, 2023, at 1002 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran went to the Brookfield Township Police Department (BTPD) to search a 2010 Dodge truck, black colored, with Ohio temporary license plate P630794 attached.

SA Moran met with BTPD Chief Faustino and he escorted SA Moran the BTPD impound lot surrounded by fencing. SA Moran took several photographs of the exterior of the truck and the interior of the truck. SA Moran located several documents and a yellow legal pad on the front seat underneath the center armrest. The documents had odd writings and notes on them. SA Moran collected the documents. The only other documents in the truck were located in the rear seat area. Those documents were in a dark colored nylon folder system. SA Moran looked at the documents inside the folder and they appeared to be work estimates, a copy of Wild's driver's license reinstatement, and documents related to Wild attending drug court in 2020. SA Moran did not collect these documents.
