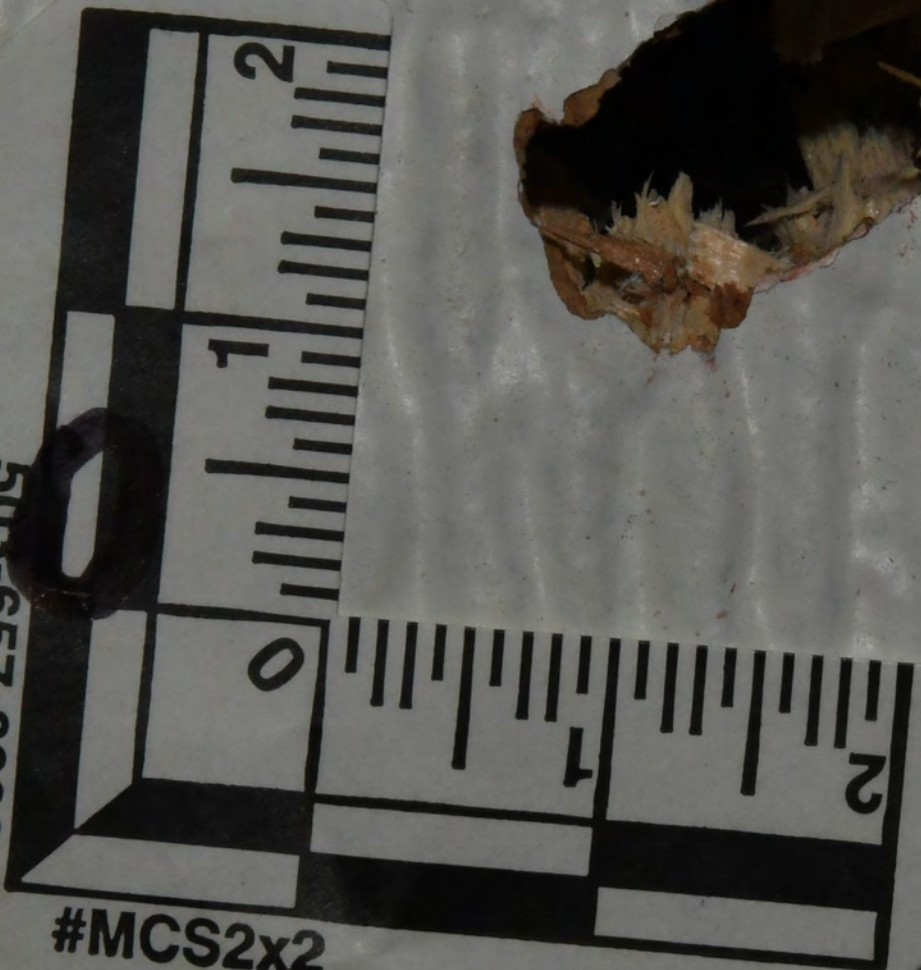

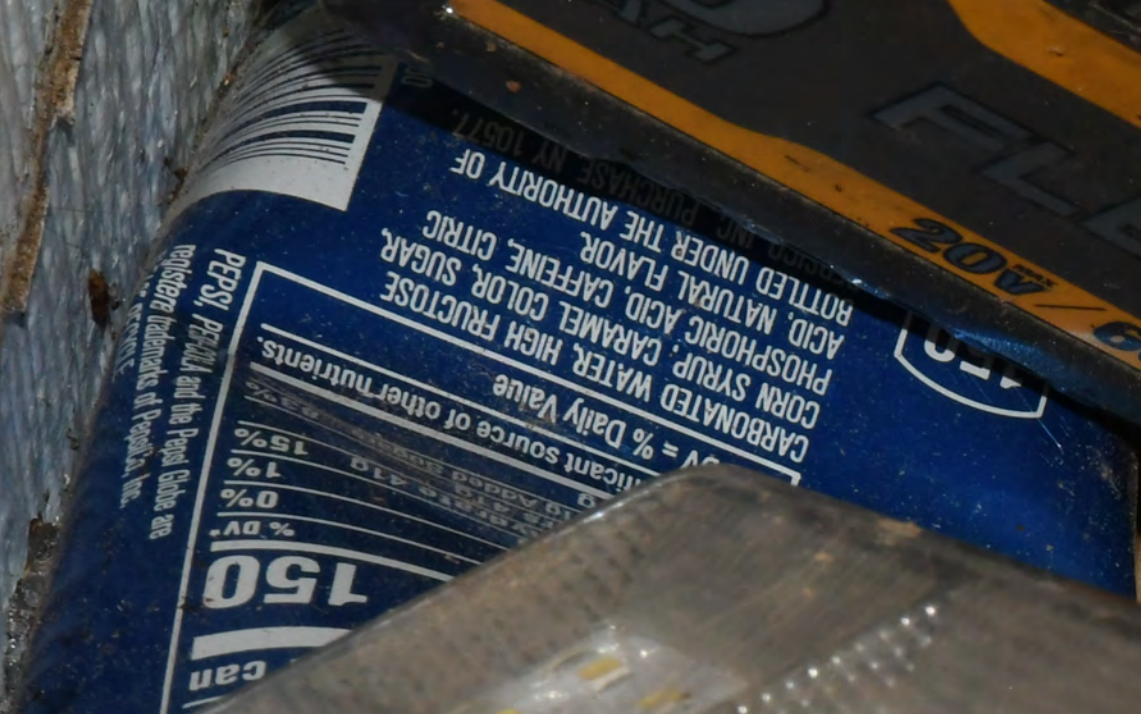

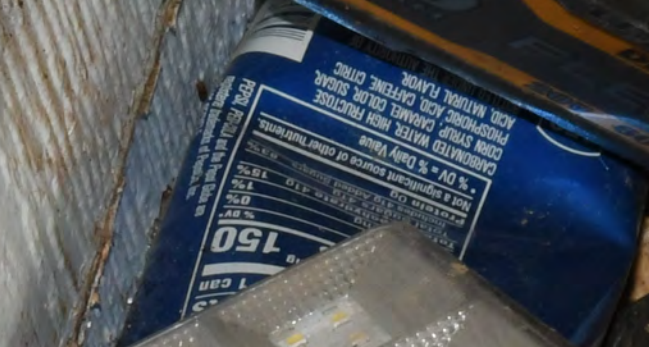

GREETINGS: An affidavit having been filed before me by Deputy Jesse Reynolds, a law enforcement officer assigned to the Jackson County Sheriff's Office, being first sworn as to the truth of the facts set forth in the affidavit for a search warrant filed with the court in this matter in which he is the affiant, and which is attached to and made a part of this warrant, and which the court has reviewed.

WHEREAS, I find from said affidavit that there is probable cause to believe that:

- In the County of Jackson, Ohio, the following criminal offense has occurred, to wit: violation of Section 2922.13 of the Revised Code (Having Weapons Under Disability), Section 2913.21 of the Revised Code (Criminal Trespass) and that William Beach committed those offenses.
- That the following described persons or items of property are connected with the commission of said offense(s), to wit: Any evidence of the offenses listed in Paragraph "I" of the Search Warrant, including any weapons (baton, handgun, or any other) and the person of William Beach.
