APPROVAL—RESERVOIR LAND LEASE, STATE OF OHIO, THROUGH CONSERVATION COMMISSIONER, TO THE OHIO POWER COMPANY, NEWARK, OHIO, FIFTEEN YEARS, ANNUAL RENTAL, \$1.00, RIGHT TO CONSTRUCT AND MAINTAIN A POLE LINE FOR ELECTRICAL ENERGY OVER DESIGNATED WATERS, BUCKEYE LAKE, PERRY COUNTY, OHIO.

HON. L. WOODDELL, *Conservation Commissioner, Columbus, Ohio.*

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio through you as Conservation Commissioner to The Ohio Power Company of Newark, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$1.00, there is leased and demised to the lessee above named, the right to construct and maintain a pole line for the transmission of electrical energy over the waters of Buckeye Lake from a point on the south shore of Buckeye Lake being at or near Station 476+50 of Schlafley's survey of the south side of Buckeye Lake and extending thence northerly, 483 feet to the center of Lewis Island, being in Section 6, Town 18 North, Range 17 West, Thorn Township, Perry County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed thereon and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
