Investigative Request

On Sunday, May 12, 2024, Detective Kevin Ishler #54 of the Shaker Heights Police Department requested the assistance of the Ohio Bureau of Criminal Investigation's (BCI) Special Investigations Unit (SIU) and Crime Scene Unit (CSU) in conducting an independent investigation into the facts and circumstances surrounding an officer-involved shooting incident. The incident reportedly occurred on May 12, 2024, at 16100 Van Aken Boulevard, Shaker Heights, Ohio 44120 and resulted in the death of De'Shawn Vaughn (Vaughn). This report will explain how Vaughn was potentially shot in the lower portion of his body by law enforcement, but that Vaughn's death was ultimately the result of a self-inflicted gunshot wound.

Preface:

This report serves as a synopsis of the investigation into the May 12, 2024, officer-involved shooting in Cuyahoga County, Ohio. This report only summarizes the information that the investigative team determined to be the most useful in achieving an overall understanding of what occurred in this incident. Every fact and detail is not presented in this summary report. Therefore, it is recommended that each individual report from which this document is derived be read in order to obtain a complete understanding of this investigation. Further, audio and/or video recordings exist for the majority of the interviews conducted, revealing further details of statements given regarding the incident.

This investigation was conducted with the purpose of determining, to the extent possible, the facts and circumstances surrounding this incident. As unbiased collectors of fact, the investigative team has not and will not render any opinion of the legality of officers' actions. Instead, it is anticipated that this investigation will provide the basis of information for decisions to be rendered by the appropriate authorities.

Investigative Team

BCI Special Agent Andrew Harasimchuk (SA Harasimchuk) was assigned as the lead SIU case agent. SA Harasimchuk received assistance in the investigation from Assistant Superintendent Mark Kollar (Assistant Superintendent Kollar), SA Stacey Fifer (SA Fifer), SA Charles Synder (SA Synder), SA Ryan Emahiser (SA Emahiser), SA Joshua Rammel (SA Rammel), SA Christopher Hamberg (SA Hamberg), SA Tiffany Najmulski (SA Najmulski), and SA Jesse Bynum (SA Bynum), SA Nicholas Valente (SA Valente), SA Matthew Armstrong (SA Armstrong), and SA Cory Momchilov (SA Momchilov). BCI SA Daniel Boerner and Crime Scene Technician Michael Rostocil of the Crime Scene Unit processed the scene of the incident by documenting, preserving, and collecting possible evidence. BCI SA William Conn of the Cyber Crimes Unit conducted an extraction and analysis of the cell phone recovered from 16100 Van Aken Boulevard #301, Shaker Heights, Ohio 44120. BCI Criminal Intelligence Analyst Andrea Bujorian of the Criminal Intelligence Unit also assisted in this investigation. The investigation was supervised by Special Agent Supervisor Charles Moran. Additionally, various personnel from the BCI crime laboratory performed scientific analyses on submitted items of potential physical evidence.

Summary of Process

The following is a partial list of investigative activities or methods which were employed during the course of this investigation, by the investigative team, in an effort to thoroughly and accurately locate and document all pertinent facts and circumstances regarding this incident:

- Recorded interview(s) of two of the four officers who discharged their weapons
- Written statements by some of the officers who were involved in the incident, at the scene, or otherwise deemed to potentially have relevant information
- Neighborhood canvas of the area surrounding the scene
- Recorded interview(s) of Ashley Crenshaw who was with the subject when the incident began
- Special agent attendance to postmortem examination (autopsy) of the deceased
- Obtained and reviewed postmortem examination (autopsy) and toxicology reports

- Obtained and reviewed police reports of prior law enforcement contacts with the subject
- Obtained and reviewed open and closed-source biographical information on the involved subjects, to include criminal history reports, OHLEG, driving records, etc.
- FBI National Crime Information Center (NCIC) checks on any non-law enforcement weapons involved in the incident (to determine if reported stolen)
- Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) trace on any non-law enforcement weapons involved in the incident (to determine ownership history)
- Review of the officers who discharged their weapons body cameras when available
- Review of drone video footage
- Review of robot video footage
- Review of all available surveillance video which captured any portion of the incident
- Processing of the scene for potential evidence (photographing, searching, measuring, documenting, and collecting)
- 3D scans / model of incident area
- Review of the department's reports, photographs, and investigative materials pertaining to the incident, excluding any Garrity statements or information derived from any compelled statement
- Consent search of the cell phone that the subject was using during the incident and performed an analysis of the data present
- Reviewed data obtained from aforementioned items of electronic evidence
- Conducted forensic laboratory examinations to include:
 - 1. Firearm identification testing of involved firearms, casings, and bullets

Incident Summary/Overview

On Sunday, May 12, 2024, at approximately 1645 hours, the Ohio Bureau of Criminal Investigation (BCI) was requested by Detective Kevin Ishler of the Shaker Heights Police Department to conduct an independent investigation into the facts and circumstances surrounding an officer-involved shooting which occurred at 16100 Van Aken Boulevard, Shaker Heights, Ohio 44120. BCI agents responded to the scene and learned that the shooting incident involved Vaughn, and multiple northeast Ohio law enforcement officers, including special weapons and tactical teams. The incident developed into a barricaded subject situation. It was reported that Vaughn was shooting a firearm during the standoff. Vaughn was the suspect in the May 11, 2024, homicide of Euclid Police Department (EPD) Officer Jacob Derbin (Derbin) #14. At various points during the standoff, two Euclid police officers, one Cleveland Heights police officer and one Elyria police officer returned fire. The incident concluded when Vaughn was found deceased inside the bathroom at 16100 Van Aken Boulevard #301 by law enforcement officers. On May 14, 2024, the Cuyahoga County Medical Examiner's Office reported through open-source media that Vaughn died from a selfinflicted gunshot wound.

The following is a brief timeline of events that led up to Vaughn being found deceased from a self-inflicted gunshot wound to the head:

On May 12, 2024, at approximately 1000 hours, an arrest warrant was obtained for Vaughn by BCI agents. Refer to the investigative report titled **Arrest Warrant Obtained**, in BCI case #2024-1472 for further details.

On May 12, 2024, at approximately 1130 hours, United States Marshal Services (USMS) had located Vaughn at 16100 Van Aken Boulevard #301.

On May 12, 2024, at approximately 1200 hours, Euclid Police Department Captain/Eastside Departments Enforcement Group (EDGE) SWAT Commander Mike Janson (Captain Janson) was notified that Vaughn had been located. Captain Janson then contacted members of the EDGE SWAT team and had them respond to the area where Vaughn was located.

On May 12, 2024, at approximately 1247 hours, members of the USMS made contact with a female, Ashley Crenshaw (Crenshaw), who was inside 16100 Van Aken Boulevard #301. Crenshaw was escorted out of the apartment by law enforcement personnel. Crenshaw advised members of the USMS that Vaughn was inside this apartment. Members of the USMS reportedly gave commands to Vaughn for Vaughn to come out

of the apartment. Vaughn reportedly refused these commands. Members of the USMS reportedly utilized two robots that were equipped with cameras and guided the robots into the apartment. Vaughn was reportedly lying underneath the bed in a "defensive position" holding a firearm that was pointed towards the door.


On May 12, 2024, at approximately 1310 hours, Captain Janson met with Enforcement Supervisor Deputy United States Marshal (SDUSM) Josh Lowe (Lowe). Captain Janson requested that the EDGE SWAT team assume control of the barricaded subject operation. SDUSM Lowe agreed to have EDGE SWAT assume control of the operation. At that time, Captain Janson became the overall scene commander along with assistance from EPD Detective/EDGE SWAT Assistant Commander Dave Carpenter (Detective Carpenter). EPD Officer/EDGE SWAT Senior Team Leader Joshua Schultz (Officer Schultz) assumed command of the operation inside the apartment building. Detective Carpenter requested that EPD detectives obtain a search warrant for 16100 Van Aken Boulevard #301.

On May 12, 2024, at approximately 1328 hours, it was reported that multiple shots that disabled the Recon Robotics Throwbot. Vaughn	then reportedly

Officer Schultz advised members of EDGE that Vaughn had "murdered a police officer, shot a civilian multiple times, posted to Social Media his intentions to fight and cause others serious physical harm, was currently armed and taking up fighting/ambush positions, had discharged the firearm in an occupied residential structure jeopardizing everyone in the area during the current engagement, and refused to acknowledge verbal commands to surrender or speak with police."

On May 12, 2024, at approximately 1331 hours, Captain Janson issued a "Delta Order" to all EDGE personnel. This message was also conveyed to USMS personnel. Captain Janson stated that "This order was given to shoot Vaughn if he came into view of any officers on scene."

Captain Janson then directed EDGE SWAT/CHPD Officer John Ciccone (Officer Ciccone) to fire baton rounds with a 40mm multi-launcher at the north bedroom window in an



effort to knock down the shades that covered the windows which prevented law enforcement from seeing into the apartment. Officer Ciccone reportedly fired approximately 30-40 foam and wood baton rounds. The rounds broke most of the glass, but the shades remained mostly intact.

EDGE SWAT members devised a plan to use the windows of apartment #401 and a long pole to reach down and remove the shades from the window in apartment #301 (Image #2). After multiple attempts only a small section of the shade was removed. This opening showed that something had been propped up against the window blocking the view into the room.

EDGE SWAT then formulated another plan which would use a robot with an explosive charge on the bedroom door. Captain Janson was going to have EDGE SWAT/EPD who were both positioned as snipers on the rooftop to "deploy sniper rifle fire during the explosive breach."

Drone operators from the ground unsuccessfully attempted to use a drone to look inside of the bedroom window. The drone was then flown inside of the apartment through the bedroom window. Vaughn swatted the drone with his hand knocking the

drone down and disabling it. Law Enforcement officers then began firing less lethal 40mm baton, CS, and OC rounds into the bedroom through the window (Image #3).

On May 12, 2024, at approximately 1620 hours, another drone was flown into the bedroom in an effort to verify Vaughn's location. Vaughn also disabled this drone by swatting it down.

On May 12, 2024, at approximately 1655 hours, an explosive charge was placed on the bedroom door. As the explosive breach was discharged the snipers alternately fired their rifles into the north bedroom window. Approximately 20 rounds were fired by the snipers at this time. Additionally, 30-40 baton/CS/OS rounds were fired into the window at the same time. The apartment door was then breached with shotgun breaching rounds. At that time, a muffled gunshot was reportedly heard from inside of the apartment.

On May 12, 2024, at approximately 1750 hours, using a camera from a robot, law enforcement officers observed a person lying on the floor of what was learned to be the bathroom.

On May 12, 2024, at approximately 1819 hours, entry was made into the apartment and Vaughn was found lying motionless on the bathroom floor. Vaughn "was immediately observed to have a traumatic injury to his head with severe blood loss

and a handgun was on the floor near his body." Vaughn was removed from the bathroom. Vaughn reportedly had a gunshot wound to the head as well as blood and wounds on his [Vaughns] lower extremities. Vaughn was then checked by EDGE SWAT medics who determined that Vaughn was deceased.

Autopsy Report

The autopsy report for the decedent (De'Shawn Anthony Vaughn) was obtained from the Cuyahoga County Medical Examiner's Office (CCMEO). A review of those documents revealed the following information:

The autopsy examination of Vaughn was performed by Dr. Elizabeth Mooney (Mooney) of the CCMEO on May 13, 2024. The findings of Dr. Mooney indicated that Vaughn had sustained four gunshot wounds.

Crime Scene Processing

The BCI Crime Scene Unit was requested to respond to the scene in order to document and preserve any items of potential evidence. Multiple agents responded and processed the scene, to include photographing and mapping the area, as well as the search for, documentation, and collection of items of possible evidence. Detailed crime scene reports were completed with the below information only summarizing some of the more significant findings.

The scene was processed by BCI SA Daniel Boerner and BCI Crime Scene Technician Michael Rostocil.

The following is an overhead diagram of the exterior scene (Image #4). This diagram gives a general idea of where the cartridge casings were located that were "source identified" to law enforcement officers firearms. Additionally, crime scene personnel noted that the apartment exhibited signs of less lethal device deployment and door breaching explosives.



Crime Scene personnel also noted that the body of Vaughn was examined by members of the Cuyahoga County Medical Examiner's Office. During this examination it was noted that Vaughn exhibited a suspected contact gunshot wound to the right side of his head (Images #5-6).

The following is a synopsis of the analysis of the previously mentioned items of evidence. The actual reports should be consulted as the following synopsis does not include many of the details from the full reports.

BCI - DNA

- An unknown female's DNA was the major contributor on the trigger and trigger guard area of Matrix Item #8 (Taurus, G2C, 9mm firearm, S/N ACJ267311).
- Vaughns' DNA was located on the grip of Matrix Item #8 (Taurus, G2C, 9mm firearm, S/N ACJ267311).
- Vaughn's DNA was located on the back slide area of Matrix Item #8 (Taurus, G2C, 9mm firearm, S/N ACJ267311).
- Vaughn's DNA was located on a "stain" on Matrix Item #8 (Taurus, G2C, 9mm firearm, S/N ACJ267311).

BCI – NIBIN

- The firearm (Matrix Item #8 -Taurus, G2C, 9mm firearm, S/N ACJ267311) that was located next to Vaughns body was linked to a May 6, 2024, felonious assault shooting in the City of Cleveland and to the May 11, 2024, homicide of Officer Derbin in the City of Euclid.
- BCI Firearms The BCI Firearms Section performed an analysis of the officers'
 and subjects' firearms, as well as the firearm-related evidence collected from the
 scene and autopsy. By comparing evidentiary cartridge casings/projectiles to
 known standards from each weapon, identifications were able to be made as to
 which casings/projectiles were fired from each firearm. Of the
 casings/projectiles recovered, the following identifications were made:
 - Matrix Item #8 (2024-1474) a Taurus, G2C, 9mm firearm, S/N ACJ267311 had "source identification" for firing the following items of evidence from BCI 2024-1474: Matrix Items #4-5, 9 and 11-14. It should be noted that Matrix Item #9, a cartridge case was found in the bathroom where Vaughn was reportedly located by law enforcement officers.
 - Matrix Item #8 (2024-1474) a Taurus, G2C, 9mm firearm, S/N ACJ267311 had "source identification" for firing the following items of evidence from BCI 2024-1472: Matrix Items # 9, 11, 26-29, 32, 34, 35, 37, 40 and 46. It should be noted that Matrix Item # 9 was a fired bullet recovered from Officer Derbin's chest and Matrix Item #11 was a fired bullet recovered from Officer Derbin's abdomen.
 - Matrix Item #16 (2024-1474) a Tactical Machining 5.56 NATO semiautomatic rifle, Model TM-15, had source identification for firing the following items of evidence from BCI 2024-1474: Matrix Items #26-31.
 - Matrix Item # 17 (2024-1474) a Remington 30 caliber class bolt-action rifle, Model 700, had source identification for firing the following items of evidence from BCI 2024-1474: Matrix Items #36-41.

"Source identification" means "The observations provide extremely strong support for the proposition that the evidence originated from the same source and the likelihood for the proposition that the evidence arose from a different source is so remote as to be considered a practical impossibility."

"Inconclusive" means "The observations do not provide a sufficient degree of support for one proposition over the other. Any use of this conclusion shall include a statement of the factor(s) limiting a stronger conclusion."

- BCI Cyber Crimes Unit
 - o Processed the Apple iPhone for forensic information connected to Vaughn. This cell phone belonged to Ashley Crenshaw (Crenshaw). Crenshaw advised investigators that the cell phone was hers. Additionally, one of the Apple IDs associated with the device was and multiple applications within the device were associated with Crenshaw. Crenshaw reported to law enforcement that Vaughn was using this cell phone, and that Vaughn logged into his [Vaughn's] Instagram account on it.
 - While reviewing the cell phone analysis an image of Vaughn lying on a bed with what appeared to be a bloodlike substance on his face and a firearm on his chest was located (Image #7). This image was taken with Crenshaw's cell phone on May 12, 2024, at 1504 hours.

Witnesses

Interview of Ashley Crenshaw - May 12, 2024

Ashley Crenshaw (Crenshaw) was interviewed by BCI SA Stacey Fifer (Fifer) on May 12, 2024. Vaughn was in Crenshaw's apartment located at 16100 Van Aken Boulevard #301, Shaker Heights, Ohio 44120, when the standoff situation began.

Crenshaw stated that she fell asleep around 0100 to 0110 hours, and she got a call from "him" (Vaughn). Crenshaw answered the phone and said everything was "normal." Crenshaw indicated Vaughn was a friend, rather than a boyfriend or ex-boyfriend.

Crenshaw said Vaughn told her he needed to come over, and she told him "OK." She told him to call her when he was outside her apartment. Crenshaw explained her relationship with Vaughn as a "friendship that had intimate moments." SA Fifer asked Crenshaw if Vaughn said why he needed to come over and Crenshaw said, "No, it was normal except for the fact...normally he'll come over...around 8 or 9...it just was later...but I didn't really look at it...was a big deal because it was a Saturday night."

When Vaughn arrived, Crenshaw said he used the apartment "buzzer", which rang to her cell phone, and she let him inside the apartment building. Crenshaw did not know the exact time Vaughn arrived because she went back to sleep until he called from the buzzer outside the apartment. Crenshaw could only say for certain that it was sometime after 0100 hours. After Crenshaw buzzed Vaughn in using her phone, she said her apartment door was unlocked and Vaughn let himself inside. According to Crenshaw, Vaughn locked the door after he went into her apartment, which was normal.

Vaughn told Crenshaw he wanted to take a shower. While Vaughn was in the shower, Crenshaw went back to sleep. Vaughn went to sleep as well in bed with Crenshaw. Crenshaw told SA Fifer "for the record" she had not known what occurred the night before involving Vaughn. Crenshaw said she woke up early and friends were sending her articles, Instagram notifications and text messages about what happened to the Euclid Police Officer. Crenshaw said she was "scared" and "petrified" because the person being displayed online was not the person she knew regarding Vaughn. Crenshaw said she was lying next to Vaughn in bed when she was receiving these communications from various people.

Crenshaw said Vaughn was asleep, and she was "shocked" and trying to figure out if she was "dreaming". Crenshaw said she did not want to bring it up to Vaughn because she did not know what "mental state he was in." Crenshaw said she never saw a weapon or a cell phone but did notice that his clothes were wet. Crenshaw could not

recall what time she woke up that morning and said she went back to sleep at some point after she put Vaughn's clothing in the dryer (across from her unit). Regarding Vaughn's clothing, Crenshaw later described them as a matching jogging suit. Crenshaw said Vaughn never left the apartment once he got there, nor did she. When asked where Vaughn was when the US Marshals arrived, Crenshaw said they were both in bed.

Crenshaw said she was asleep when she heard the police tell them to come out with their hands up. Crenshaw said she and Vaughn did not speak at that point. Crenshaw went to the door and opened the door. SA Fifer asked Crenshaw what Vaughn's reaction was when the Marshals were there, and Crenshaw said she just jumped up and went to the door. When asked where the firearm was at that point, Crenshaw said she never saw a firearm. She described the layout of her apartment and explained she was in bed asleep, so she never saw anything except his clothing and a small "fanny pack." Crenshaw claimed the fanny pack was not big enough to "fit a gun."

When asked why Vaughn's clothing was wet, she said did not know, but assumed it was from rain or sweat. Crenshaw explained that she stepped on Vaughn's wet clothing that was on the floor near the bed. Crenshaw discussed that she had sexual relations with Vaughn that morning as well.

According to Crenshaw, Vaughn would normally have his cell phone, and he did not have it with him. The number Vaughn called her from earlier that day was from a number that she did not recognize. SA Fifer asked Crenshaw if she had a conversation with Vaughn about what had happened. Crenshaw said Vaughn told her he was "into stuff" and "had a lot going on", and he had a situation with his "baby mother brother". Crenshaw said Vaughn just told her he had "shit going on."

SA Fifer asked Crenshaw if she honestly did not know what happened that night. Crenshaw said she "knew something happened" but was adamant that she had no knowledge of a police officer being killed. Crenshaw described Vaughn as having a "poker face" and that she feels like she did not really know him.

SA Fifer asked Crenshaw if Vaughn used her cell phone while he was there. She did not recall if Vaughn used it to call or text anyone, but he did have her cell phone at some point.

Interview of Ashley Crenshaw - May 16, 2024

On May 15, 2024, SA Fifer received a phone call from Attorney Adam Brown (Attorney Brown), who relayed that he represented Crenshaw. Attorney Brown indicated Crenshaw was a "victim" and wanted to make an additional statement to investigators.

On May 16, 2024, Attorney Brown, Crenshaw, SA Fifer and SA Harasimchuk met at BCI Richfield.

Crenshaw provided additional information regarding the incident, her interactions with Vaughn, and she consented to a search of her cell phone.

SA Fifer asked Crenshaw what information she wanted to relay to investigators. At the incident scene, Crenshaw said she only told police officers or detectives things pertaining to that day and during the "standoff." Crenshaw said she wanted to add that she had a conversation with "Shawn" (Vaughn) on Tuesday evening of that same week (May 7, 2024). Crenshaw said it was normal that she did not speak with Vaughn every day. On Tuesday, Vaughn asked Crenshaw where she was and Crenshaw told him she was at her grandmother's house even though she was at home. Crenshaw indicated she was trying to distance herself from Vaughn. Vaughn wanted to know if Crenshaw still had the spare key to his car. Crenshaw told him yes, and he asked her to return his spare key to his mother. Crenshaw said Vaughn sent a screenshot of a text message he sent to his mother with Crenshaw's information.

Additionally, Crenshaw said Vaughn sent two photos to her. One photo was a "mug shot" of Vaughn from 2021 and the second photo was a "screenshot" of an article from the "Cleveland Remembrance Page" on Instagram. Crenshaw said the article had to do with a shooting near "140th." Crenshaw asked Vaughn about it and Vaughn replied, "This is what they want me for." Crenshaw was on the phone with a friend and sent the screenshot to her friend at the time. Crenshaw and Vaughn exchanged a couple more text messages about the referenced article and, according to Crenshaw, Vaughn replied, "It is what it is." Crenshaw described Vaughn as a "tough guy" person and a lot of things he said did not register to her.

Crenshaw said she returned Vaughn's car key the following day to his mother. Also, on Wednesday, Crenshaw said Vaughn sent her a link to "Turo.com" car rental place that showed a white Volkswagen vehicle. Crenshaw said under the link Vaughn asked Crenshaw if she could get the car for him, please. Crenshaw made up a lie and told Vaughn someone stole her wallet, so she could not rent him a car. According to Crenshaw, Wednesday morning was her last contact with Vaughn "before Saturday." Crenshaw thought she was done with Vaughn after returning his car key because that was the only item she had, which belonged to Vaughn.

Crenshaw confirmed when Vaughn reached out to her after 0100 hours on May 12, 2024, he called her from a phone number she did not recognize, and she believed it

was a "303" area code (Image #8). Crenshaw agreed to see Vaughn, and he came over to her apartment (Image #9). Crenshaw was unsure how Vaughn got to her apartment, and she was unaware of any vehicle Vaughn may have used to get there. Regarding Vaughn's clothing being wet when he arrived, Crenshaw said she asked him if it was raining outside. She reiterated that nothing was "out of the ordinary" on her end. SA Fifer asked Crenshaw if Vaughn made any statements about what he had been involved in earlier in the evening. She said he did not. When asked if Vaughn had a bag or backpack with him, Crenshaw said if he did, she would not have seen it because the lights were off, and she was in bed.

Vaughn took a shower at Crenshaw's place and got in bed with her. Crenshaw said it was "so late" that it was "almost morning" at that time. Crenshaw woke up first and had text messages on her phone from her friends about "what had happened." Crenshaw said she was trying not to show a reaction in front of Vaughn to the text messages. Crenshaw denied having any conversation with Vaughn about the context of the text messages she received from friends, and she started calling her friends to tell them to stop sending her "things." Crenshaw talked to her friends "Marissa" and "Donald". Crenshaw said Vaughn used her cell phone, and she did not know why Vaughn did not have his cell phone. Crenshaw said she did not know what he did on her phone except that she did see him log into his Instagram. Crenshaw said she was "scared" bringing up anything to Vaughn, and she tried to "act as normal as possible."

SA Fifer asked Crenshaw if, at any point, she asked any of her friends to call the police and Crenshaw said no because Vaughn was right next to her the whole time she was on the phone. Crenshaw said once she found out about "the officer", she could not stay still and kept finding reasons to get up from bed. She said she was nervous, felt

sick and needed to "throw up." Crenshaw said she went to the first-floor bathroom of her apartment building and threw up and used the bathroom. She did not recall what time this occurred in the morning. Crenshaw confirmed her apartment was on the third floor of the building. When asked if she thought about leaving, Crenshaw said she was scared because she felt like Vaughn was watching her, and she said her mind was not thinking how her "normal mind would." Crenshaw said she did not want to do anything "out of the norm."

Crenshaw returned to her apartment and Vaughn was still in her bed. She stepped on Vaughn's wet clothing that was on the floor near her bed. Crenshaw put Vaughn's clothing in the dryer (across from her unit). Crenshaw called her mother and Vaughn was listening to her conversation. Crenshaw said she laid back down in the bed until she heard the police at the door and Vaughn told her to "go." Crenshaw confirmed she did have sexual relations with Vaughn that day at her apartment and claimed she only did that to "act normal."

SA Fifer asked Crenshaw if she had control of her phone or if Vaughn had control of her phone while he was there. Crenshaw said anytime Vaughn asked for her phone, she gave it to him because she did not want to upset him in any way. She claimed she was terrified of Vaughn and she never saw him with a weapon that day.

SA Fifer asked Crenshaw if she knew anyone who could have rented Vaughn a white Volkswagen. She did not know and said she heard Vaughn posted about who rented the Volkswagen on Instagram. Crenshaw did not recall who told her that information. Crenshaw added that after she was out of the apartment when the police were there, Vaughn continued to use her cell phone, speaking with her friends and her sister. Crenshaw said Vaughn told her sister, Melissa, he had to see Crenshaw one last time, to tell her he was sorry, and he loved her.

killed an officer and shot at officer's multiple times. (18:42)" When asked if he believed Vaughn was intentionally firing at him as he got into position on the roof, stated he did believe that.

Officers sent additional robots into the apartment from the hallway. Every time a robot was sent into the apartment, Vaughn would shoot it, break it, cover it up, or otherwise interfere with it.

Officers sent a drone into the subject apartment through the window. Vaughn again fired bullets at the drone that was flown through the open window. At that point in time, had received reliable information from other officers that Vaughn was barricaded between the exterior brick wall in the corner of the apartment bedroom and a mattress. believed his bullets would not have been able to penetrate the brick wall and strike Vaughn, so he did not try to shoot through the wall.

"It was determined that we were gonna try to um, flush him out at that point, after several hours. So, they were trying to hang an explosive breach on the door. Um, and they wanted suppressive fire while they were trying to send officers up to um, to lay that breach on the door. So, uh, Assistant SWAT Commander, um, David Carpenter, he's also from Euclid, he um, asked for the snipers to shoot some rounds through the window in a downward angle. Um, and that's what I did. I shot, um, he wanted it to last a long time. He wanted just controlled fire to try to distract him while we were shooting foam rounds through the window, the 308 rounds through the window, while they were trying to hang the charge. Um, so I did that. I probably fired for I guess the whole situation took place several minutes. I don't know how many. I would guess between three and four minutes. Um, after that we ceased fire. Um, about a minute to two minutes later I heard a muffled pop, um, coming from that area. It sounded like (a) gunshot but muffled. Um, after, you know another hour and a half or so they put a dog in and they found that Mr. Vaughn had uh, shot himself in the head and that was it. (21:22)"

When asked, explained that he received the delta order both over the radio and during a conversation he had directly with SWAT Team Commander Jansen as the two communicated directly from the roof and ground below. stated he believed he first asked Captain Jansen if a delta order was in place and Captain Jansen said yes. Captain Jansen later reported the delta order over the radio.

When asked what the decision for the delta order was based on, said "It's based on, he's already a credible threat, he's already fired (at) officers, he's confirmed killed an officer so, it's a totality of all the information that you have about him that yeah. (24:58)"

When asked, confirmed that when he fired his rifle, he did so for the purpose of providing cover to the officers assigned to place the breach on the door.
When asked, confirmed all of his shots were fired during the time the officers were placing the breach charge on the door of the apartment.
When asked, stated he never actually saw the subject through the window of the apartment.
When asked what his point of aim was, stated his point of aim was just above where he believed Vaughn's feet were based on the information relayed to him by other officers.

On June 25, 2024, SA Valente spoke with Attorney Tom Hanculak via telephone after exchanging emails attempting to schedule a date and time to interview the involved Euclid Police
Attorney Hanculak advised SA Valente during the phone call that neither officer would participate in a formal interview with BCI agents.
<u>Dispatch-Related Information</u>
It was reported that the EDGE SWAT, which was the law enforcement organization that took command of this situation did not operate on a recorded radio channel. Therefore, there was no radio traffic to review.
<u>Video Recordings</u>
It was determined that only the body-worn camera (BWC) footage from the involved officers would be reviewed. Additionally, the recorded drone video footage and BWC footage from the law enforcement personnel operating the robots was reviewed.
were not wearing BWCs. BWC footage was reviewed and due to the placement of BWC during most of the video footage, the viewer is unable to see what was able to see. BWC did not visually capture any video footage that depicted images of what law enforcement personnel were seeing when they discharged their weapons.
The drone video footage and video footage from the robot operators did not capture any portion of the actual officer-involved shooting.



Conclusion

Vaughn committed suicide by shooting himself in the head during the course of a law enforcement action that occurred when law enforcement personnel were attempting to arrest Vaughn for the in the line of duty death/homicide of Officer Derbin. While law enforcement was attempting to arrest Vaughn, Vaughn created a barricaded subject

situation. During the barricaded subject situation, Vaughn reportedly fired a handgun at law enforcement officers and law enforcement equipment. Law enforcement personnel discharged their weapons during this standoff situation, possibly striking Vaughn in the lower portion of Vaughn's body.

The only item of evidence recovered from the bathroom where Vaughn's body was located besides from Matrix Item #8 (Taurus, G2C, 9mm firearm, S/N ACJ267311) was Matrix Item #9 (cartridge case) which was source identified to Matrix Item #8.

Additionally, Vaughn's DNA was found on multiple areas of Matrix Item #8 (Taurus, G2C, 9mm firearm, S/N ACJ267311).

Matrix Item #15 (bullet fragments that were recovered near the window that was in the bedroom that Vaughn was observed in) and Matrix Item #54 (bullet fragments that were recovered from the left thigh and knee of Vaughn) were not fired from Matrix Item #8 (a Taurus, G2C, 9mm firearm, S/N ACJ267311), Matrix Item #16 (a Tactical Machining 5.56 NATO semi-automatic rifle, Model TM-15, S/N [100]), or Matrix Item #19 (a Sig Sauer 5.5mm NATO semi-automatic rifle, Model SIGM400, S/N
