Narrative:

Search Warrant Obtained

Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) drafted a search warrant for medical records for James Haynes from OhioHealth-Mansfield Hospital, relative to the officer-involved critical incident which occurred on July 29, 2021.

On Thursday, August 26, 2021, SA Goudy met with Richland County Court of Common Pleas Judge Phillip S. Naumoff (Judge Naumoff). Judge Naumoff reviewed the search warrant, search warrant affidavit, and request/order to seal. On August 26, 2021, at approximately 1100 hours, Judge Naumoff signed/authorized the search warrant.

Search Warrant Executed

On Thursday, August 26, 2021, at approximately 1130 hours, SA Goudy executed/served the aforementioned search warrant by submitting a paper copy to the OhioHealth-Mansfield Hospital medical records department. Employee Diana Rinehart received the court order and produced the medical records via DVD for James A. Haynes immediately after. The DVD contained 112 pages of medical records containing the life-saving emergency care and treatment provided to Haynes by OhioHealth staff.

During the search, the following items of potential evidence were seized:

• One DVD containing the medical records of James A. Haynes from July 29, 2021 to July 30, 2021.

An inventory of the items seized was prepared with a copy provided to the BCI case file as item #61.

Search Warrant Returned

On Tuesday, August 31, 2021, SA Goudy met with Judge Naumoff. Judge Naumoff reviewed and signed the search warrant return. On August 31, 2021, SA Goudy filed the original search warrant, search warrant affidavit, inventory and search warrant return with the Richland County Clerk of Courts.
