NARRATIVE

CIT/Noise Complaint

While assigned to 4A31 accompanied by PO Mandzak #1235 we received a radio broadcast to respond to the corner of Spafford and Canton in connection with loud music.

Upon our arrival we heard loud techno/EDM music being admitted from 7702 Spafford. We looked through the window to see a white male pacing around the home. I shined my flashlight in the home to get his attention. The male looked at me and continued to pace around the home but now began speaking into a microphone which broadcast his voice on the speaker system. The male was rambling about various topics and was not making much sense.

We ran the license plate of the vehicle in the driveway of the home, and it came back to Robert Perkins (suspect/victim). The male inside the home matched the description of Perkins. I also recognized Perkins from seeing him in the area before. PO Mandzak then knocked on the side door and instructed the Perkins to turn the music down, to which Perkins spoke into the microphone answering in the negative.

Perkins has been a victim of a CIT in the past (24-004733). Perkins also has a history of having firearms on him and in his home and discharging them illegally (24-004709/24-007385). Perkins also has a history of inducing panic and lighting fires (23-265403).

After being unable to make contact with Perkins, I spoke to S33 Sgt. Brown.

We returned to the district and completed a Misdemeanor Summons for City Ord. 683.01 "Playing of Sound Devices Prohibited; When".
