Narrative:

On October 22, 2024, at 1721 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente met with SA Dan Boerner and took possession of all 24 evidence items collected from the scene and hospital by BCI agents. SA Valente signed an evidence transfer receipt noting he took possession of these items.

SA Valente transported the evidence items noted above to the BCI Richfield Office. All evidence was placed in temporary evidence locker #10, at 1830 hours except for item #18, a paper bag containing wet clothing, which was placed in a secure evidence drying chamber. The evidence receipt was updated and placed in temporary evidence locker #10 with the evidence items.
