Narrative:

On July 26, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Chuck Moran (Moran) began reviewing body-worn camera (BWC) video files for this case.

SAS Moran located two BWC video files on the SIU shared drive for Ashtabula County Sheriff's Office (ACSO) Deputy Helfer. They were labeled:

2. Helfer 2 of

SAS Moran made working copies of each video and placed them in a folder on his BCI-issued laptop. The working copies of the videos were used for the review.

SAS Moran imported the videos into Amped Replay for review.

SAS Moran reviewed the video file labeled, "Helfer 1 of" first. SAS Moran noted the following information:

- The video-embedded timestamp date was 2024-05-31.
