Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (Momchilov) received a copy of Warren Police Officer [REDACTED]'s (Officer [REDACTED]) personnel file and training records.

SA Momchilov reviewed both files and documented the following:

Personnel File

Officer [REDACTED] was appointed by the Warren Police Department on November 10, 2014.

Officer [REDACTED]'s file shows that he received three Letters of Commendation, a Letter of Recognition from the Trumbull County Prosecutor's Office, two Letters of Appreciation and a Top Cop Award Nomination.

Officer [REDACTED] shows one disciplinary action. On November 2, 2028, Officer [REDACTED] was in a marked police cruiser on the police ramp in a parking space. In an attempt to assist another officer on a traffic stop, Officer [REDACTED] backed his cruiser up the ramp. In doing so, Officer [REDACTED] struck an unmarked vehicle causing damage. Officer [REDACTED] was given a one-day suspension for causing the damage.
