Narrative:

On Tuesday, July 5, 2022, at approximately 1240 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) went to Range USA, a firearm dealer and gun range, located at 812 Killian Road, Akron, Summit County, Ohio, 44319. At the business, SA Tingley initially contacted Evan Schoonover (Schoonover), Assistant Store Leader. SA Tingley requested that due to the nature of the contact, the conversation be conducted in a private location, rather than in the general area of the business open to the public. Schoonover had SA Tingley follow him to the onsite training room; after sending another employee to contact Ryan Esselburn (Esselburn), Store Leader, and have Esselburn come to the training room as well. Shortly after arriving at the training room, SA Tingley and Schoonover were joined by Esselburn. SA Tingley explained the nature of the investigation regarding Jayland Walker (Walker) and asked if Range USA had any records involving Walker. Esselburn went to his office, in order to check for the records, while Schoonover explained the general procedures regarding public access and use of the gun range at the business.

A short time later, Esselburn returned and was holding three register receipts. Esselburn advised that the first two receipts were from June 7, 2022. He stated that Walker was at the gun range with a Dupri Whatley and that both signed Range USA waivers, in order to use the range on June 7, 2022. Overall, the receipts indicated: the charge for two liability waivers; the rental of a single lane at the gun range; rental of a set of ear muffs; rental of a set of rugged eye protection; and the purchase of four 50-round boxes of MWA remanufactured 9mm ammunition.

The third receipt that Esselburn had was dated June 20, 2022, and showed a customer name on the receipt of Jayland Walker. The receipt shows that Walker purchased the following: a Glock model G45 9mm handgun (serial # BVXA 810); a 20-round box of SIG Elite Performance 9mm 124 grain jacketed hollow point bullets; and a set of Walkers Foam Ear Plugs.

SA Tingley inquired as to any video that Range USA would have of both the gun range session and the purchase of the firearm. Schoonover stated that there would be video both from the

gun range and from the counter where Walker would have purchased the firearm. Schoonover advised that he would fill out and send the request form to the Range USA Corporate Asset Protection Office; which maintains all of the video records for the business, as well as copies of the waiver forms and other paperwork signed by Walker. SA Tingley then gave Schoonover a business card, which listed SA Tingley's BCI work phone number and BCI email address. Schoonover advised that the Corporate Asset Office would email the requested videos directly to SA Tingley's BCI email.
