Narrative:

On Tuesday, December 17, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Eric Lehnhart (SA Lehnhart) compiled background information on Shane Linderman (Linderman), a subject involved in the incident on Tuesday, September 10, 2024. The information included researching past police reports involving the subject, searching criminal history records, court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit and the Youngstown Police Department.

SA Lehnhart reviewed the information and noted the following:

Prior Police Encounters:

Due to Linderman's limited time in Ohio, Sgt. Sharon Cole of the Youngstown Police Department advised that their department had no reported interactions with Linderman prior to the incident on Tuesday, September 10, 2024.


