5. The total membership in the society shall not at any time exceed five hundred.

Section 9491, General Code; Opinion of Attorney General No. 3483, rendered to you August 5, 1931.

Since the proposed articles of incorporation of Sans Souci Mutual Aid do not comply with the pertinent statutes of Ohio, I am compelled to advise that same should not be filed by yourself in their present form.

The transcript does not contain affidavit in proof of publication of the notice of election as required by the then provisions of Section 5649-9b, General Code. These provisions with respect to the notice of election upon the question of issuing bonds are now substantially incorporated in Section 2293-21 of the Uniform Bond Act. This office has consistently taken the position that those provisions are mandatory and in the absence of a finding by a court of competent jurisdiction that there has been substantial compliance with the law in this respect, I am compelled to advise you not to purchase these bonds.

This contract covers the construction and completion of 1 7'0"x200' Stack Complete, with Burkett Lightning Rod System, as specified, for Massillon State Hospital, Massillon, Ohio, in accordance with the form of proposal dated October 17, 1931.
