Narrative:

On November 25, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Lamping (SA Lamping) requested Matrix item 058 (Personal Items Recovered at Autopsy) to be removed from evidence storage to be analyzed. AP Betsy Turney (AP Turney) removed the item and transferred custody to SA Lamping.

SA Jesse Bynum (SA Bynum) and SA Lamping opened Matrix item 058 and removed the contents. Inside of the evidence envelope were several items packaged separately in heat sealed bags to include one yellow light from the sock worn on right foot, two plastic bags with a crystalline substance from sock worn on left foot, pair of black handcuffs and orange metal wire from the body card.

SA Lamping opened the heat-sealed bag containing the two plastic bags with a crystalline substance from the sock worn on left foot. SA Bynum removed one of the bags and opened the zip top and removed a representative sample. SA Bynum performed a presumptive test for methamphetamines using a Sirchie Nark II test kit. After breaking the ampule and agitating the test kit SA Bynum was able to confirm that the substance tested positive as containing Methamphetamine / Amphetamines. The zip top bag was resealed and placed back into the heat-sealed evidence bag. SA Lamping resealed the bag and placed it along with the other heat-sealed bags into the evidence envelope and resealed it with tape.

SA Lamping returned Matrix item 058 to AP Turney to be secured in evidence.
