Comments: Case Synopsis: On July 29, 2021 the Officers Clay Blair and Mark Boggs of the Mansfield PD were involved in an officer involved shooting. The officer responded to the 300 Wood St for a 911 hang up. After arriving the officers heard a Jaron Von Ginn calling for help. The officers saw James Haynes holding a knife in front of an apartment. The officers ordered Haynes to drop the knife. Haynes refused and a taser was deployed. Haynes began complaining through the window of the apartment still armed with the knife were Ginn was calling for help. Officers shot Haynes, who was transported to a hospital were he died from his injuries. Officers learned that Haynes had stabbed Ginn multiple times with a knife.
