Narrative:

On Wednesday, January 31, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) received an Ohio BCI Cyber Crime Unit report for an item of evidence submitted on January 22, 2024 for scientific analysis (Cyber Crime case number 2023-3223). The report was authored by Computer Forensic Specialist Natasha Branam and was dated January 28, 2024. The items relevant to this report which had previously been submitted were as follows:

Once the Cellebrite Reader is open the content can be examined and any additional reports can be generated. It is necessary to note that Item 5 has a last recorded factory data reset time of November 5, 2023 4:40 PM.
