Narrative:

On September 22, 2025, at approximately 1145 hours, Ohio BCI Special Agents Lauren Frazier (SA Frazier) and Steven Seitzman (SA Seitzman) interviewed Patrick Foley's parents, Cecil Foley and April Foley. The interview took place in the Springfield Police Department investigation conference room. Also present for the interview was their adult daughter and Attorney Patrick Conboy. The interview was not recorded. The purpose of the interview was to gather all pertinent information known or observed by the family regarding Patrick Foley's history, medical treatment, and prognosis.

Cecil stated that he had requested Patrick's medical records from Miami Valley Hospital on September 19, 2025. Attorney Conboy advised that they wanted to voluntarily provide the medical records to investigators. Attorney Conboy and Cecil Foley filled out a BCI Consent to Search form, authorizing agents to have a copy of the medical records for Patrick Foley from Miami Valley Hospital. A copy of the consent form has been attached to this report. The medical records were received via email from Attorney Conboy on September 24, 2025. The medical records will be documented and reviewed in a separate report.

SA Frazier asked April and Cecil to talk about Patrick. April stated that Patrick was an athlete and a good person. She said that in his senior year of high school, he got into a crowd with the wrong people. Since then, Patrick got involved with drugs and had traffic related interactions with the police. April said that Patrick fled from the sheriff's office previously for not having a license and was sentenced to a year at London Correctional Institution. April said that Patrick worked as a tree trimmer and was very good at climbing trees.

April went on to say that the only reason that Patrick would have run from the police was because his license was suspended. April said that the truck that Patrick was driving belonged to him. She said that Patrick bought the truck less than a month ago

from a work client. She said that the vehicle was registered in someone else's name because Patrick's license was suspended.

April said that Patrick used to date a female named Jasmine Williams. April and Cecil did not know the Black female who was believed to be with Patrick on the day of the incident. April said that she learned that after Patrick had fled from the police, that Patrick called his friend, Tre'on Hutchins. April said that Tre'on's mom lives in the neighborhood where the incident occurred. April spoke to Tre'on, who she said was very upset about Patrick's passing. Attorney Conboy provided SA Frazier with a phone number of for Tre'on. SA Frazier asked if Patrick had any connection to the house that Patrick and the female were seen near when the incident began. April stated that they do not know anyone else in Springfield.

On the day of the incident, September 16, 2025, April said that she was contacted by a Springfield Police detective at approximately 1459 hours. She said that she and Cecil arrived at the hospital around 1630-1700 hours. April said that she was told that Patrick had hit his head on a rock. April could not recall who she heard this information from.

April said that Patrick's trauma doctor at Miami Valley Hospital was Dr. Jay. April and Cecil described that Patrick's injuries consisted of swelling, facial fractures, skull fractures, and broken heart syndrome. Cecil said that doctors told them that Patrick had so much pressure in his eyes that he was most likely paralyzed, blind, and/or unable to function on his own. April stated that she believed that at one point, she was wiping brain matter from Patrick's nose. Cecil said that nurses removed several pieces of gravel from Patrick's face, during treatment.

Cecil Foley took numerous photographs of Patrick while he was at the hospital, between September 16-19, 2025. Five (5) photographs were provided to Attorney Conboy, who forwarded the photographs to SA Frazier on September 23, 2025. All photographs received have been attached to this report. Shown below are two of the photographs received.

On Friday, September 19, 2025, April explained that doctors at Miami Valley Hospital performed numerous tests on Patrick to check for brain activity. The tests included a physical exam, brain stem function test, apnea test, and four-vessel nuclear scan. After performing these tests, April and Cecil stated that Patrick was determined to have no brain activity. Around 1700 hours, an additional brain stem function test was performed and Patrick did not have any brain function. At this point, Patrick was pronounced by medical staff as deceased due to being brain dead. April stated that Patrick wished to be an organ donor. Therefore, Patrick's body was placed on life-support, pending organ donation.
