**Search Warrant Obtained:**

On July 7, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matthew Armstrong drafted a search warrant for location detail records relative to an Officer-Involved Critical Incident June 27, 2022. The search warrant was specifically related to T-Mobile cell phone number 330-945-0365, which was assigned to Jayland Walker.

On July 8, 2022, at 1300 hours, SA Armstrong met with Summit County Court of Common Pleas Judge Kelly McLaughlin who reviewed the search warrant, search warrant affidavit, non-disclosure order, application to seal and order to seal. Judge McLaughlin signed/authorized the search warrant, non-disclosure order, and order to seal.

**Search Warrant Executed:**

On July 8, 2022, SA Armstrong executed/served the aforementioned search warrant by submitting it to T-Mobile via email. Specifically, SA Armstrong submitted it to the following email addresses:

On July 8, 2022, T-Mobile sent a confirmation email which indicated the tracking ID for the submission was 3900995.

On July 14, 2022, at approximately 0855 hours, SA Armstrong received an electronic copy of the requested records from T-Mobile via email. They have been placed on a CD and stored in the BCI SIU case file as Reference Item G. A copy of the records was provided to the BCI Cyber Crimes Unit for analysis.
