On March 30, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent James Poole (SA Poole) received copies of the medical records for Jajuan Ball (Ball), from Grant Medical Center (Grant). The medical records were obtained via an Investigative Subpoena through the Franklin County Municipal Court. These records are regarding the injuries of Ball as a result of an Officer Involved Critical Incident which occurred on February 24, 2022. A copy of the records will be maintained electronically within the case file. Please refer to the records for specific details.

On March 31, 2022, SA Poole reviewed the medical records for Ball. Ball was transported via emergency squad to Grant Hospital on February 24, 2022, with Traumatic injuries from an auto crash.
