Narrative:

On the morning of June 16, 2023 at approximately 0300 hours, as part of a neighborhood canvass, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) James Gore met with residents at 502 Foster Avenue, Cambridge, Ohio. The purpose of the contact was to ascertain whether or not the residents witnessed anything regarding an Officer–Involved Critical Incident which took place on the previous evening at 428 Foster Ave.

SA Gore first spoke with the homeowner, Brian Villeda. Villeda said he was working in Columbus when the events took place. Villeda's home was equipped with a video camera system, but he stated that it did not record the police activity. Villeda showed SA Gore a clip from the system on his phone, which appeared to depict several people rushing into the front door of his residence after what sounded like a gunshot was heard in the background. Villeda attempted several times to share the video clip with SA Gore via email, but he was unsuccessful. Mr. Villeda said that another person who was present captured a portion of the shooting activity with his phone. That person was identified as J-Shin Perry.

Mr. Perry showed the video he had on his phone, which appeared to have been taken from a west-facing window on the second floor of 502 Foster Ave. The video depicted officers in tactical uniforms maneuvering around vehicles on Foster Avenue while gunfire was exchanged with a subject who was out of the camera's view. SA Gore attempted to download the video from Perry's phone, but he was unsuccessful at doing so. Perry agreed to share the video with SA Gore once the technical issues with his phone were resolved.

On the evening of June 22, 2023, J-Shin Perry sent a copy of the video from his phone to SA Gore via email. According to Perry, the recording began at 17:28 hours (June 15th), but he did not capture the initial gunfire exchange because he was busy running into the house when that took place.

The following screenshots from the video were taken by SA Gore; some were labeled for context.

At approximately 18 seconds into the video clip, what sounded like four pairs (possibly 8 shots, or 4 shots with echoes) of gunfire were heard in rapid succession. Simultaneously, airborne particles and debris were observed from bullet strikes to a vehicle on the roadway. A woman's voice could also be heard screaming in the background.

At approximately 23 seconds into the video, an officer positioned next to the black Jeep sport utility vehicle parked on the roadway was observed returning fire (in the direction of 428 Foster Ave.); the officer appeared to have fired three shots in rapid succession.

At approximately 28 seconds into the video, another officer was observed moving back from the black Jeep to another position of cover.

At approximately 41 seconds into the video, the officer who returned fire was observed shooting two more rounds in the direction of 428 Foster Ave. Another officer moved from the black Jeep back to another position of cover.

At approximately 52 seconds into the video, the officer who fired shots moved from the black Jeep to another position of cover. Seconds later in the background, a woman's voice was heard screaming, 'Taurean, please come out!' among other things.
