Narrative:

On Thursday, October 23, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent James Gore (SA Gore) completed a review of background information regarding Dominique Byrdsong (Byrdsong). Mr. Byrdsong was mortally wounded during the critical incident involving Grove City Police on October 8, 2025. The information was obtained from criminal history records, correspondence with other law enforcement agencies, and open-source searches. The computerized criminal history (CCH) information was obtained by the BCI Criminal Intelligence Unit (CIU) via the Law Enforcement Automated Data System (LEADS).

Upon reviewing the data, SA Gore noted the following:

Open-Source Searches:

An internet search (Google) was performed using Dominique Byrdsong's name as the search term. Most of the results pertained to the Grove City incident and previous criminal activity (incarcerations, mugshots, etc). Mr. Byrdsong's LinkedIn profile indicated that he had experience as a Class A-licensed commercial driver for Goodwill. A GoFundMe fundraising page for Byrdsong, organized by Alexandra Poole (former girlfriend of Byrdsong), was also located. A sampling of the open-source search results was compiled into a single document and is available for review as an attachment to this report.

Prior Police Encounters:

Law enforcement databases were queried, and correspondence was had with involved agencies to identify Dominique Byrdsong's previous contact with police. A pattern of suspicious behavior and criminal activity was observed, with the most notable being the following:

- June 15, 2016: Pataskala Police responded to an aggravated menacing complaint, on which Dominique Byrdsong was found to possess four syringes of

suspected heroin, related paraphernalia, and a handgun magazine. Mr. Byrdsong's brother, Desmond Byrdsong, was in possession of a handgun (incident #06-19420-16).

- May 27, 2024: Columbus Police were dispatched to a suspicious vehicle call. Dominique Byrdsong was found to be impaired and in possession of a Canik TP9 handgun. Byrdsong was issued a summons (incident #240377679).
- August 20, 2025: Knoxville Police (Tennessee) responded to a call for service from Dominique Byrdsong. The dispatch notes stated that Byrdsong sounded confused, and he wanted to speak with an officer. The notes further indicated that Byrdsong thought that someone was trying to steal his car, and that he had been running from people all night. The call was cleared without any additional documentation (incident #P25192011).
- September 24, 2025: Columbus Police responded to a parking lot on Roberts Road on a suspicious person call. The caller reported that a male, later identified as Dominique Byrdsong, was attempting to get into her parked car. Byrdsong reportedly told the caller that the vehicle was identical to his own, and that his own car had recently been stolen. Officers arrested Byrdsong on an outstanding warrant, and he reportedly forcibly resisted the arrest (incident #250704176).
- October 2, 2025: Hilliard Police responded to a suspicious person outside of a billiard hall and bar, where staff members observed Dominique Byrdsong urinating outside near the front door. The responding officer reported speaking with "Alex" (Alexandra Poole) via phone regarding Byrdsong's condition. Alex alleged that Byrdsong was experiencing some sort of psychosis, and that he had earlier made threats to "off himself with his blicky (gun)." Byrdsong reportedly denied to the officer that he wanted to harm himself, but he did admit to having no sleep in the previous twenty-four hours. It was the officer's determination that Byrdsong did not meet the criteria for an involuntary commitment for psychological evaluation. Byrdsong was released with his firearm in the trunk of his vehicle, per the call notes (incident #252750017).
- October 5, 2025: Columbus Police responded to a complaint of a suspicious person at a private parking lot near the airport. Byrdsong reportedly told the lot manager that he was waiting for a friend at that location. A simple police field interview was conducted to document the interaction (incident #25F000983).
- October 7, 2025: Pickaway County Sheriff's Deputies responded to an automotive service center in Harrisburg regarding a stolen vehicle complaint. The shop owner reported that sometime during the prior evening, a black Ford F-800 truck was stolen from the property. Deputies located a black Chevy Tahoe registered to Dominique Byrdsong in a wooded area nearby. A subsequent

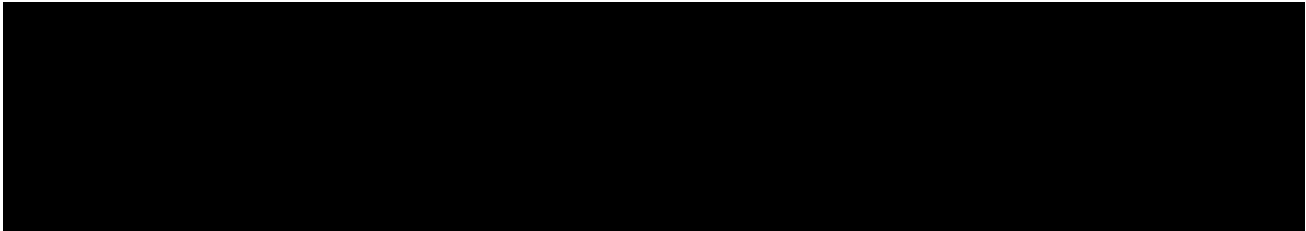
search warrant conducted by deputies on the vehicle yielded Byrdsong's birth certificate, a Walther gun case, and several packets of kratom (incident #SO-CR2503086).

(Note: Kratom is a controversial drug, derived from a plant native to Southeast Asia. It has made recent notoriety in Ohio, as Governor DeWine has sought to have the Board of Pharmacy classify it as a controlled substance. Kratom is not yet classified as a controlled substance at the federal level, though several states, including neighboring Indiana, have banned its use and possession.)

The incidents described above were also compiled into a single document, available for review as an attachment to this report.

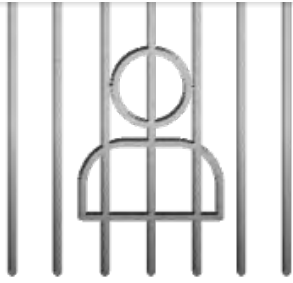

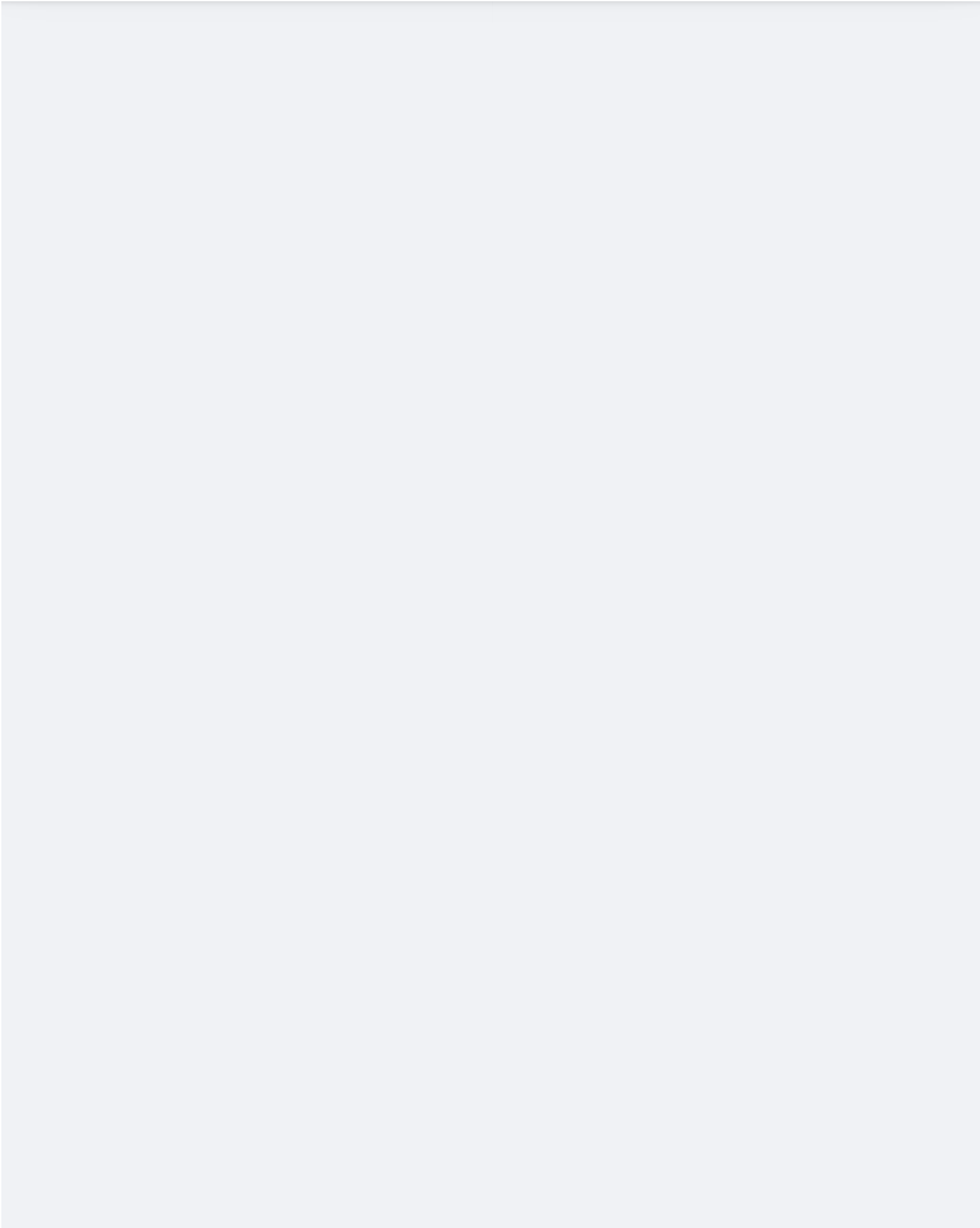

Grove City police identify burglary suspect shot and killed by officers after barricade

Grove City police have identified the burglary suspect shot and killed by officers Wednesday night as 32-year-old Dominique Byrdsong.

A police statement released Friday said Byrdsong fired at officers after they say he fled from a home he was barricaded in for more than three hours.

Officials said evidence, including witness statements, indicate Byrdsong fired his handgun at least twice.

Police said one officer was shot. That officer, who has not been identified, was taken to a hospital and has since been released.



A body cam video released Friday by Grove City police shows an officer chasing a man down a street at night. The officer yelled several times and ordered the man to get on the ground.

Police appear to pursue the man toward a house when multiple shots were fired. There is no clear view of the man.

According to police, other officer body cams fell off during the pursuit or were obstructed by gear.

Authorities said the truck the suspect parked in the driveway of the home was reported stolen on Tuesday in Pickaway County.

The name of the officers who shot Byrdsong have not been released.

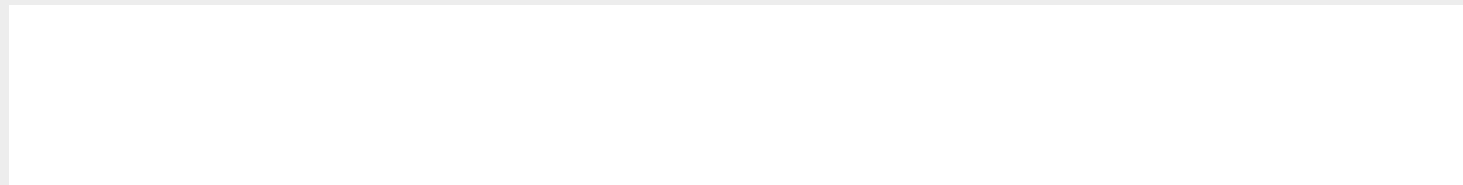

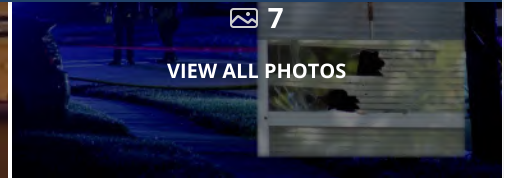
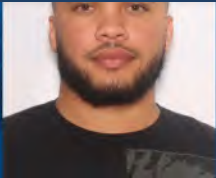

COLUMBUS, Ohio (WSYX) — Grove City police identified the man killed by officers on Wednesday after a burglary led to an officer being shot.

Dominique Byrdsong, 32, died after a nearly three-hour barricade situation at a home on Louise Court. The homeowner told officers that a man was inside a vacant property—armed with a loaded gun—and refusing to leave.

Around 8:30 p.m., Byrdsong ran from the house and led officers on a foot chase. Police said evidence indicates he fired a pistol at officers at least twice, with one officer shot.

The other officers then returned fire, fatally wounding Byrdsong.

A neighbor told WSYX that she noticed the man behaving suspiciously the day before the shooting and that he was parked in the driveway in a black utility truck. That truck was later determined to have been stolen out of Pickaway County on Tuesday, the day before the shooting.

The wounded officer was released from the hospital on Thursday. "We are grateful for all the support from our community," Grove City police said in a statement.

The department released three video clips from body cameras showing some of the barricade situation and the moments leading up to the gunfire. A spokesperson noted that some officers' cameras either fell off during the foot pursuit or were covered by gear.

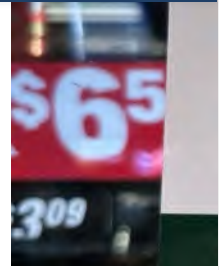

Grove City police officer released from hospital

COLUMBUS, Ohio — The Grove City Division of Police confirmed in a press release that the officer who was [shot by a suspect](#) Wednesday as he fled a three-hour long barricade situation has been released from the hospital and “is doing well.”

What You Need To Know

- Grove City police received a report of a burglary at 5:15 p.m. Wednesday, and the suspect barricaded himself in the home
- After a foot chase, the suspect fired at officers, injuring one
- Officers fired back at the suspect, who died, the department said

They also identified the suspect involved in the shooting—who they have said died—as Dominique Byrdsong, 32.

The Grove City Police Department said it received a call at 5:15 p.m. for a burglary at 3810 Louise Ct. The homeowner said there was a man in the house with a gun.

When officers arrived, they set up containment and tried to order the suspect to surrender.

Police said the suspect barricaded himself inside the home, and the Grove City Strategic Response Team came to the scene.

At 8:37 p.m., the suspect ran from the house on foot, police said. After a foot pursuit, the suspect fired shots at officers, striking one. Officers fired back.

Both the suspect and the injured officer were taken to the hospital.

The release references witness statements showing the suspect fired at least two shots at officers.

"We are grateful for all the support from our community," the release reads.



What we do know is that the person we saw in those last moments was not the real DJ. We also know that there were many missed opportunities where help could have been given, and it breaks us to know that this tragedy might have been prevented.

DJ was kind, funny, and loved by so many. The way he left this world does not define him.



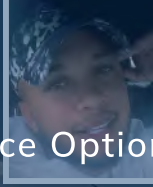

On 10/09/2025 this unit Detective Robert Dauberman, was made aware Grove City Police Detectives were requesting a warrant to be drafted for entry into the abandoned vehicle registered to Dominique Byrdsong. This vehicle was recovered as abandoned on the lot in which the Ford F-800 belonging to [REDACTED] was stolen from.

It was presumed the abandonment of the Chevrolet Tahoe belonging to Mr. Brydsong, was related to the theft of the Ford 800.
