### Narrative:

On Sunday, March 16, 2025, at approximately 0400 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Eric Lehnhart arrived at 220 South Park Way, Ravenna, Ohio 44266, the Ravenna Police Department to interview multiple witnesses and one victim from an incident that happened near 645 Hazen Avenue. This incident resulted in the death of Shawn Ware.

Prior to the interviews, SA Lehnhart was contacted by Special Agent Joe Goudy (SA Goudy). SA Goudy was seeking consent to enter 645 Hazen Avenue, Apt. 3 to photograph and collect any items of evidentiary value.

SA Lehnhart contacted Becky Lynn Clark (Clark), the resident of that apartment and explained the reason for BCI's request to enter her apartment and presented a consent to search form for her review.

With the assistance of SA Lehnhart, Clark read, signed, and approved BCI personnel to enter and search her apartment for evidence.

The completed consent to search form was scanned and attached to the corresponding electronic Matrix case file and was attached to this investigative report.
