**Narrative:**

On June 1, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (Momchilov) and SA Andrew Harasimchuk (Harasimchuk) interviewed Shanon Turnquist (Shanon) at her residence 2125 Tryon Road, Ashtabula. Shanon and her husband Dwayne live across the street from John Perry's Residence.

SA Momchilov advised Shanon that it was his understanding that there was an incident that occurred across the street. Shanon advised that was correct. SA Momchilov asked Shanon if she could explain what occurred.

Shanon explained yesterday she had her dogs outside, when she looked up and observed her neighbor, John Perry (Perry), outside in his driveway, pointing a gun at her. Shanon also stated that her 7-year-old daughter and 8-year-old niece were also outside when this occurred. Shanon gathered the kids and her dogs and went inside.

SA Momchilov stated, "So, basically, you have your dogs out and you look up and he's pointing a gun at you?" Shanon replied, "Yeah." SA Momchilov asked if Perry said

anything to her. Shanon advised he did not. SA Momchilov asked if she had previous encounters with Perry. Shanon replied, "Never, I've been here for like 5 years."

SA Momchilov asked Shanon what she thought Perry's intentions were. Shanon replied, "I don't know, I know when ever he did open his mouth, it was yelling and it was only, yesterday I've heard it and maybe a few weeks ago when he went up to get his mail he started yelling at me, taking my dog out, just yelling."

SA Momchilov asked Shanon what she observed once deputies arrived. Shanon stated the deputies waited until Perry's nephew (Nathan Lukkarila) arrived on scene. Nathan knocked on Perry's door while the deputies stayed by the garage area. Shanon advised that Perry, "Finally came out with his gun, pissed off and told all three of them to get the fuck off his property."

SA Momchilov asked Shanon if she observed the shooting. Shanon stated she observed it from inside her house. Shanon stated, "I don't know what, he come out his window, but he opened them blinds and then bang, bang, bang."

SA Momchilov asked Shanon if she could tell who was firing. Shanon stated she believed the police were firing and did not know if Perry had fired. Shannon stated it happened fast.

Shanon also stated she has a video of the shooting. Agents were later able to obtain that video (See Investigative Report titled, "Cellular Phone Video Footage from Dwayne and Shanon Turnquist" for further detail). Still images from Shanon's cellular phone video are also documented in the Investigative Report titled, "Interview with Dwayne Turnquist."

The interview with Shanon was recorded via audio. The audio recording is attached to this Investigative report.
