**Narrative:**

On June 8, 2023, at approximately 0145 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Arvin Clar (Clar) obtained the clothing worn by Jeffrey Neff (Neff) at the time of his death from Mercy Hospital Emergency Room #8, 1320 Mercy Drive NW, Canton, Ohio. SA Clar transported the clothing to BCI, 4055 Highlander Parkway, Richfield, Ohio. SA Clar secured the clothing in the drying room at 0225 hours on June 8, 2023.

On June 15, 2023, at approximately 1330 hours, SA Nick Valente (Valente) removed the clothing from the drying room. SA Valente examined the clothing. SA Valente noted the clothing consisted of a red t-shirt, grey sweatpants, two black socks, and a pair of Nike tennis shoes. SA Valente observed red staining on the t-shirt and sweatpants. Five defects were observed in the t-shirt. Two of these defects appeared to be cut or tear marks and were located near the waistline of the garment. The three remaining defects appeared consistent with being caused by ballistic penetration. These three defects were located on the left shirt sleeve, right shirt sleeve, and the center chest area of the garment. SA Valente photographed the clothing and those photographs were attached to this report. After examining and photographing the clothing SA Valente placed the garments in a brown paper bag which was sealed and marked as Matrix Evidence Item 36.

SA Valente secured the clothing in temporary storage locker #40 at approximately 1410 hours on June 15, 2023.

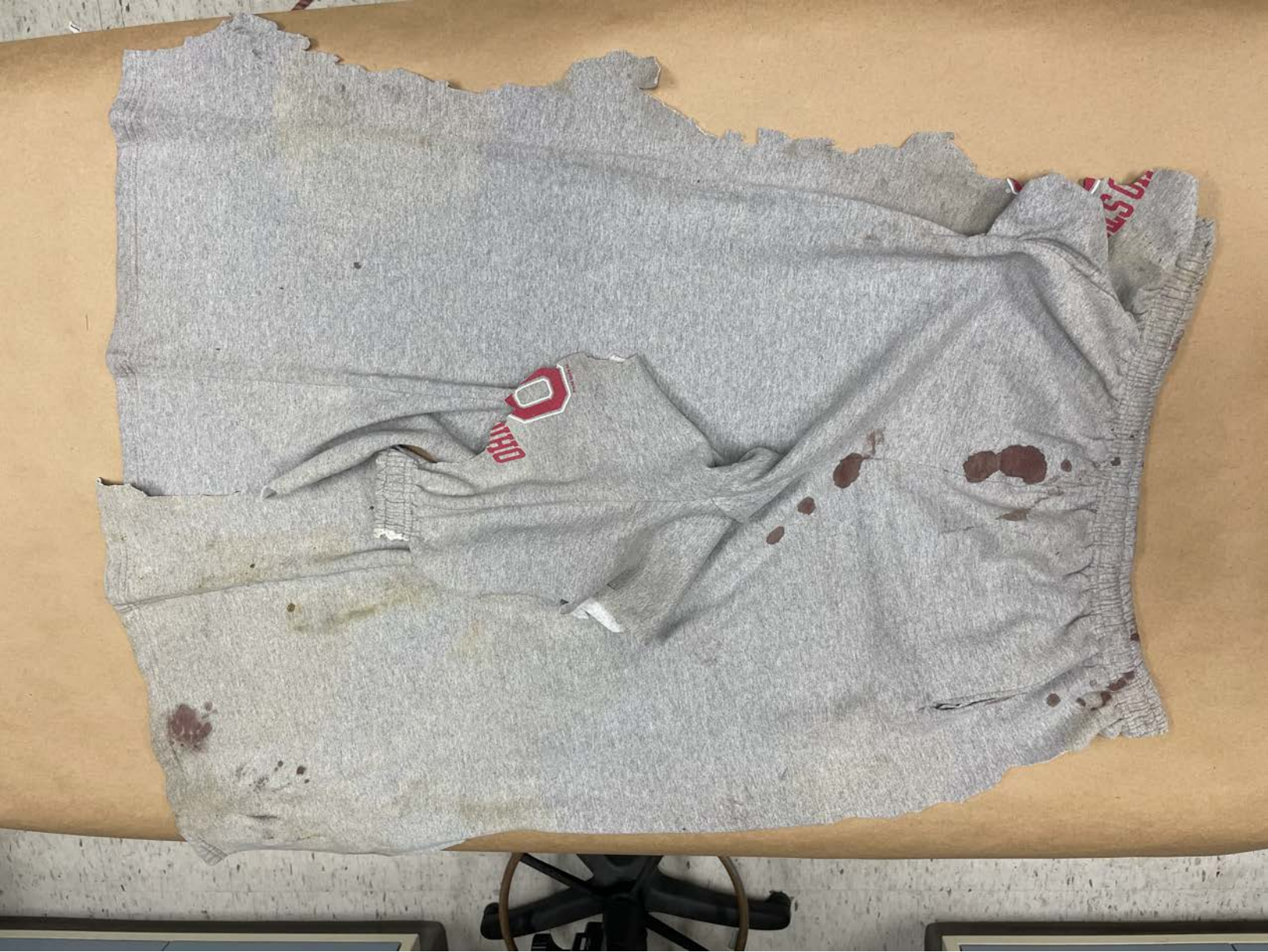
