

**Investigative Activity**: Evidence Transported to BCI

#### Narrative:

On Sunday, September 3, 2023, at approximately 1424 hours, the Ohio Bureau of Criminal Investigation (BCI) Crime Scene Unit (CSU) and Special Investigations Unit (SIU) responded to an officer-involved critical incident which occurred at Ave., Alliance, Ohio 44601.

SA Larry Hootman (Hootman) collected the physical items of evidence from the crime scene. Special Agent (SA) Nick Valente (Valente) collected the involved officer's firearm.

At approximately 1825 hours, SA Hootman met with SA Armstrong at the scene. The items of evidence collected from the crime scene were turned over to SA Armstrong who then transported them to the BCI Richfield office located at 4055 Highlander Parkway, Richfield, Summit County, Ohio 44286.

SA Valente transported the collected firearm to the BCI Richfield Office where it was turned over to SA Armstrong at 2100 hours.

At 2110 hours, SA Armstrong secured all the items of evidence in Temporary Evidence Storage Locker #1.
