**Narrative:**

On July 5, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jon Lieber (Lieber) received records previously requested from the Youngstown Police Department (YPD). The records received included the body-worn camera (BWC) videos of the YPD officers that were on scene at [REDACTED] Youngstown, OH at the time of the Officer-Involved Critical Incident on June 13, 2024. This report will detail the BWC videos from multiple officers.
