DEAR SIR: You have submitted for my examination and approval a reservoir land lease in triplicate executed by you as Conservation Commissioner to one Stella Lathem Inskeep of Columbus, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$24.00, payable in semiannual installments of \$12.00 each, there is leased and demised to the lessee above named, the right to occupy and use for cottage site and docklanding purposes, the inner slope and waterfront and the outer slope and borrow pit in the rear thereof that is included in the northerly fifty feet of the north end of Embankment Lot No. 88, west of the waste gates at Buckeye Lake, as laid out on the northerly shore of Buckeye Lake by the Ohio Canal Commission in 1905, and being part of the north-half of Section 22, Town 17, Range 18, Fairfield County, Ohio. Said fractional lot has a frontage of fifty (50) feet measured on a line nineteen (19) feet back from the top of the stone retaining wall on the east shore of the new reservoir at Buckeye Lake. This lease is a renewal of a lease originally granted to Dr. J. O. Lathem under date of May 17, 1921.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner, acting on behalf of the state of Ohio, and by Stella Lathem Inskeep, the lessee therein named.
