APPROVAL—LEASE OF CANAL LANDS EXECUTED BY THE STATE OF OHIO TO OLIVER E. RAGER OF GROVEPORT, OHIO, FOR ABANDONED CANAL LANDS IN THE VILLAGE OF GROVEPORT, FRANKLIN COUNTY, OHIO.

HON. CARL G. WAHL, *Director, Department of Public Works, Columbus, Ohio.*

DEAR SIR: This is to acknowledge the receipt of your recent communication with which you submit for my examination and approval a certain canal land lease in triplicate executed by you as Superintendent of Public Works and as Director of said department to one Olive E. Rager of Groveport, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$72.00 payable in semi-annual installments of \$36.00 each, there is leased and demised to the lessee above named the right to occupy and use for business and yard purposes that portion of the abandoned Ohio Canal in the village of Groveport, Franklin County, Ohio, which is bounded and described as follows:

Commencing at a point in the northwesterly line of the state canal property where the same is intersected by the northerly line of Main Street in said village and running thence easterly across the canal and its embankments, one hundred and five (105') feet, more or less, to a point in the southeasterly line of the state canal property where the same is intersected by the northerly line of Main Street, as now located; thence northeasterly along the southeasterly line of the state canal property one hundred and sixty (160')
