Officer Involved Critical Incident – 428 Foster Ave, Cambridge (L)

**Investigative Activity:** Radio Traffic Review, Records Received

**Narrative:**

On July 27 and August 7, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent Kyle Douglass (SA Douglass) received radio traffic audio files and incident reports from Cambridge Police Department (CPD) Captain Dave Peoples (Cpt. Peoples). This documentation was requested by BCI in order to investigate an Officer-Involved Critical Incident (OICI) which occurred on June 15, 2023, at 428 Foster Avenue in Cambridge, OH. It was reported that CPD SWAT officers were involved in an encounter with Taurean Brown (Brown) at this location. During the encounter, Brown allegedly fired a weapon at CPD responding officers, and a CPD SWAT officer discharged his firearm in response. Brown was later discovered inside the residence deceased, with an apparent self-inflicted gunshot wound.

Documentation received included radio traffic audio files and CPD Incident Report # [REDACTED] and # [REDACTED]

After reviewing incident report # [REDACTED] SA Douglass noted the following:

- Assisting officers on scene at 428 Foster advised that Taurean Brown was refusing to exit the residence, and that the mother could not get him to come outside.
- Officers also advised that he did have access to firearms inside the home.
- The Cambridge PD SWAT was also activated due to Brown refusing to exit his residence and the presence of firearms inside the home.

Incident report # [REDACTED] did not contain a written narrative.

After reviewing the dispatch "CAD" notes, SA Douglass noted the following:

- 1439 HOURS RECEIVED CALL FROM FEMALE STATING HER EX TAUREAN BROWN WAS TRYING TO BREAK INTO HER HOUSE AND HER 2 YEAR OLD DAUGHTER WAS IN THE HOUSE WITH HER
- 1448 HOURS UNIT 106 ADVISED MALE SUSPECT IS ON A SMALL BLACK BICYCLE HEADED NORTH AND WEST SEEN LEAVING SCENE BY NEIGHBORS
- 1451 HOURS [REDACTED] ADVISED IF MALE SUSPECT WAS LOCATED HE WOULD BE A 21 WITH FELONY HOLD

PRIMARY NARRATIVE

While on patrol, officers were dispatched to [REDACTED] in reference to a breaking and entering in progress. Dispatch advised that she lost contact with the caller. Upon officers' arrival, PTL Eubanks made contact with the victim, [REDACTED] in which she advised that the suspect, Taurean Brown, had already left the residence prior to our arrival.

I spoke with [REDACTED] as other units left the scene in an attempt to locate Brown. While speaking with [REDACTED] she was very upset, and had marks on her face where she advised Brown had bit her.

[REDACTED] advised me that she has been in a relationship with Taurean Brown's brother, Greg Brown, for the last 7 years, and that they have a child together, Brynxli Brown. [REDACTED] advised that she lives with Greg in the residence at [REDACTED]. [REDACTED] advised that her and Greg's relationship has not been working out, and that she started to have an affair with Greg's brother, Taurean Brown. [REDACTED] advised that she found out that Taurean Brown has been sleeping with other women, so she told Taurean Brown, that she no longer wants to continue the affair.

[REDACTED] advised that today, 6/15/2023, she could not find her wallet, so she contacted Taurean Brown to see if he knew where it was. [REDACTED] advised that Taurean Brown stated that he did not have it, and asked [REDACTED] where she was, in which she replied that she was at her house. [REDACTED] advised that moments later, Taurean Brown, was at her residence, and called her on the phone to have her let him in. [REDACTED] advised that she told Taurean Brown that she did not want him inside the residence, and that she was getting ready to take a shower. [REDACTED] advised that she was in the bathroom with her daughter, Brynxli Brown, when she heard glass breaking. [REDACTED] advised that it was at this time that Taurean Brown kicked open the bathroom door, grabbed her phone, and yelled at her for calling the police. [REDACTED] stated that Taurean Brown then bit her on the face, came out into the living room and smashed the TV, walked through her bedroom, and then exited out the rear door.

I observed the TV smashed as well as broken glass all over the kitchen floor and rear entrance where Taurean Brown had broken into [REDACTED].

[REDACTED] advised that she was in fear for her life and was very afraid of Taurean Brown. [REDACTED] advised that Brown had made threats in the past to kill her even to the point of holding a gun to her chest. [REDACTED] advised me that it was a good possibility that Taurean Brown may be armed if we come into contact with him. [REDACTED] also advised that Taurean Brown may have been in a vehicle, on foot, or on a bicycle.

I then was advised by assisting units that they were out at 428 Foster, and that all vehicles were present, and that there was a bicycle in the back yard. Units also advised that the neighbors stated that Taurean Brown left on a bicycle, but did not see him return. Units attempted to make contact but did not get a response. Units advised that neighbors got in contact with his mother, Yavette Brown, and that she was in route to the residence. Units then advised that Yavette Brown was attempting to get Taurean Brown to exit peacefully. Units on scene set a perimeter.

Officers also advised that he did have access to firearms inside of the home. At this time, Detective Angler and I, came back to the police station to request a warrant for 428 Foster Ave and the arrest of Taurean Brown. The Cambridge PD SWAT Team was also activated due to Brown refusing to exit his residence and the presence of firearms inside of the home.

Once warrant was in hand, Detective Angler and myself responded to the residence.
