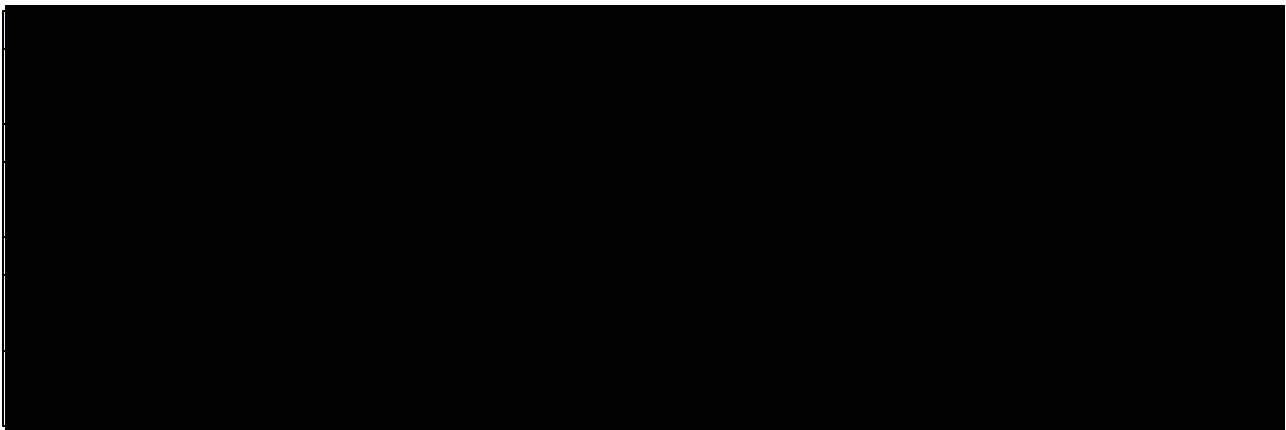
Narrative:

On Thursday, July 10, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Dan Boerner (SA Boerner) began reviewing the background information on Patrick Kerr (Kerr), a subject involved in the incident on Tuesday, June 24, 2025, in Brooklyn, Ohio. The information included researching past police reports involving the subject, searching criminal history records (CCH), court records (if applicable), open/closed-source database inquiries, and social media posts. The information gathered was obtained from the BCI Criminal Intelligence Unit, the Brimfield Police Department, the Kent Police Department, the Strongsville Police Department, and the Rocky River Police Department.

SA Boerner reviewed the information and noted the following:

Computerized Criminal History (CCH) and/or Court Records:

Kerr had a CCH with [REDACTED] cycles.

Officers were dispatched to the Kings Inn Motel #154 for a report of a welfare check. Kerr called the police on his ex-girlfriend, stating that she was going to kill herself. Officers contacted the ex-girlfriend and confirmed that was not the case. Kerr was subsequently arrested for falsification.

Call Type: Welfare Check

Officers were dispatched to 346 Harris St. for a reportedly distraught male, identified to be Patrick Kerr. Kerr's sister, Melissa Hurst, reported that Kerr was having suicidal thoughts. Contact was made with Kerr, who reported that he was fine and was currently an active patient with Summa Health.

Officers were dispatched to 346 Harris St. in reference to a request from Summa Health to check on the status of Patrick Kerr. Officers located Kerr, who stated that he was in the process of going to Summa Health. Officers confirmed this information with Summa Health.

June 23, 2025 (An empty firearm case was observed in Kerr's vehicle)

Brimfield Township Police Department - 2025-11008

Call Type: Welfare Check

Officers were dispatched to 1307 S. Sandelwood Oval in reference to a request from Kerr's ex-wife, Shanna Kruttschnitt, to check on the welfare of Kerr. Kruttschnitt reported that Kerr texted her a goodbye note. Officers were unable to make direct contact with Kerr but did physically see him. Proof of life was observed by family members later in the evening.

June 24, 2025 (This is the event that precedes the shooting)

Rocky River Police Department - 202500945

Call Type: Welfare Check

Officers were contacted by Kerr's social worker, Todd Esterburg, who reported that Kerr had just left his appointment upset. Esterburg reported that Kerr texted him with a picture of a gun and stated that he wanted to kill himself. Officers learned that Kerr had been fired this morning. Kerr was entered into NCIC with a caution to law enforcement.

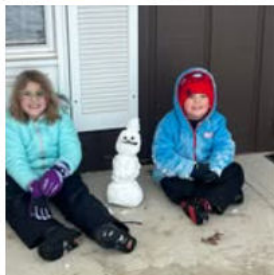
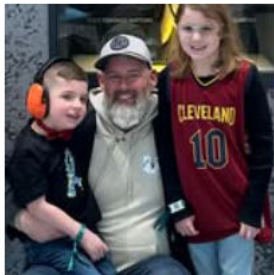

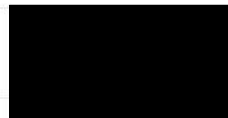

On June 23, 2025, Officers were dispatched to 1307 S Sandelwood Oval for a welfare check on Patrick Kerr. Shanna Krutchnitt, Kerr's ex-wife, stated to Dispatch that she received a text from Kerr and it was a goodbye note. The note had specific parts for her, their children, and Mr. Kerr's family and friends. Shanna also stated that Kerr had prior history of suicidal ideations.

Officer Putnam, Officer Kucinic, and myself, arrived at Kerr's residence. There was no vehicle observed in the driveway and no one answered the door. I spoke with Shanna by phone, and she advised that their divorce was recently finalized, and Kerr's mental health has deteriorated since then. Shanna sent me the long text from Kerr. Kerr mentions in the text message that he was under investigation for a sexual encounter that he believed was consensual. Kerr also stated in the text that he was a monster and he was sorry for the decision he was making. Kerr did not outright state he was going to take his own life, only alluded to it.

A short time later, Kerr was observed pulled into his driveway, left his truck running, left the driver side window down, and walked quickly into the garage of his residence. Officer Putnam attempted to speak with Kerr, and Kerr shut the garage door. I looked through the open window of Kerr's truck and observed an open firearm case on the passenger seat. The case was empty.

Officers moved away from the residence and attempted to call Kerr. Kerr's phone was going straight to voicemail. Kerr sent a text to a friend at 0813 hours telling him that he was sorry he lied about the reason he (Kerr) needed the firearm, and it was always only meant for Kerr to use. Kerr also made a post on Facebook that said "Goodbye Facebook". All calls and texts went unanswered from Kerr.

I stayed in contact with Shanna throughout the day in case Kerr reached out to her. Shanna had their children in her custody. Shanna stated Kerr has threatened suicide before (in 2022 and 2024) but he never attempted to harm himself or left a note like this time. Shanna also stated that Kerr has been very angry and erratic since the divorce. Officers attempted to contact Kerr throughout the day but were unsuccessful. Kerr's truck stayed in the driveway, parked in the same spot, all day.

At approximately 1400 hours, I met with Meghann Preseren, Kerr's sister, at Kerr's residence. Preseren used the garage door opener from Kerr's truck to open the garage. The door to the house was locked. Preseren knocked on the door and the front door. Kerr would not come to the door, or speak to anyone. Kerr's phone was still off. Preseren and officers left the residence and Preseren was going to return at a later time. At approximately 1600 hours, Preseren returned to Kerr's residence. Kerr would still not answer the phone or the door. Preseren stated Kerr's truck was now locked and the window was now rolled up, which showed that Kerr did not harm himself, but was still not contacting anyone. Preseren stated this is what Kerr does then acts like it's not a big deal. Preseren left the residence to return home and officers cleared the scene. Officers were never able to make contact with Kerr.

On the above date and time I, Ptl Moore 252, was dispatched to 346 Harris St for a reportedly distraught male, identified as Patrick Kerr. The PR, Melissa Hurst, stated her brother, Patrick, was having suicidal issues. She stated he was going through a divorce and struggles with mental health. She said he had left messages to his children and he told them goodbye. She also said he has had no contact since 1945 HRS and his phone is now off.

When I arrived I observed Patrick's only means of transportation parked in the street, a maroon KC Roofing truck. He lives in the upstairs unit and the lights were all turned on. I knocked several times and made announcements but no response. His downstairs neighbor stated that he has not heard Patrick walking around tonight. I called Melissa and spoke with her and her husband. She said Patrick's boss, identified as Floyd Sweet, was on his way. I advised them that we did not have enough to force entry into the house at this time. Although he is struggling right now he has not made direct threats and did not state he has a plan or that he wants to die. He told his kids he could not "do this anymore".

Floyd arrived on scene. I advised him how we could not go in right now. He asked if he could go in and if we would let him in. I advised Lt Gaydosh 213 of this. Floyd used to have the key to this house but gave his key to Patrick for him to use while he was in between homes due to the divorce. There was one other person, Shane Castile, who lived in this home. Shane was currently in PA and was unavailable to let us in. Floyd called Shane and asked if he would be willing to give Floyd permission to go in. Shane was on speakerphone so we could hear him. I advised him of what was going on. He stated he would allow Floyd, by whatever means, to gain entry into the home to check on Patrick. Floyd got his ladder off his own work truck and used it to get up onto the roof. He then climbed into the second floor window. He advised he did not see Patrick anywhere. I asked for him to come let us in so we could do a check also. Shane had given us, Ptl Carnahan 247 and myself, permission to also go in. We went in and made announcements but he was not found. I asked dispatch to put a BOLO out for him. His phone was still turned off and unable to be pinged and he did not have any other vehicles.

We checked some local bars to see if maybe he walked to them. Floyd advised that Patrick does not drink but he shoots pool sometimes. Dominic's and The Pub were both checked but he was not in them. Shortly after, within an hour, I was advised by dispatch that someone had called in and said Patrick was home. I went out to 346 Harris St and spoke to him. Patrick at first did not want to talk to me but he eventually did. I asked him about the threats and he said they were not threats. I asked him about the messages and he said there were not any messages. He said he was on Facetime with his kids and told them that he has stuff for all of them for them to have but that he just can not do this anymore. He said when he made that comment he was referring to how he can not be a part time dad anymore and so he just wants to give up and give up custody. He said he is not suicidal and has no plans of hurting himself. I asked if he was speaking with anyone and he said he goes to his counseling regularly and he had an appointment for tomorrow, February 6th. I asked for him to please follow through with it and to call me if he needs anything.

Due to the misinformation, no direct threats made, and Patrick stating he was fine I had no reason to pink slip him. Due to him already being in the counseling program no follow up was requested for him. He is currently an active patient with Summa Health.

No further action was taken.

The PR, Summa Health, had received information from the previous night, Ref CR 24-1707, where Patrick had made comments to his children about not being able to be a dad to them anymore. Patrick did not want to have custody due to the divorce he was going through.

Ptl Carnahan 247 observed Patrick walking into his home. He made announcements to him and Patrick stated he would talk to Officer Moore. I arrived shortly after and spoke to Patrick. He was on the phone with Cody from Townhall 2. Cody was already on his way to take Patrick to Summa Health. Patrick had already told me last night that he was going to go to Summa Health willingly and that is why Cody was already made aware of this. I spoke to Cody and he said he was going to be there in thirty minutes. Nothing had changed with Patrick since the previous night. He did not have any suicidal intentions and he did not last night either. I advised Patrick to let us know if he needs anything else. He said he would contact me when he gets out.

No further action was taken.

On 06/24/2025 at approximately 1020 Hrs I spoke with therapist Todd Esterburg over the phone at RRPD. Esterburg was on the phone to report receiving text messages from a patient that stormed out of his office earlier in the morning. Esterburg reported that he received texts from patient Patrick Kerr threatening self harm. Esterburg was unable to provide a list of medication that Kerr was prescribed, and stated he was not his physician. Esterburg emailed me the text messages from 216-727-7433. The text messages were from Kerr and expressed frustration with payment for his appointment and referenced "having a plan". Kerr attached a photo of a handgun and promised he would not hurt anyone else. Esterburg responded to Kerr to seek medical attention. After hanging up with Esterburg, he quickly called me back to report that Kerr came to the appointment with a Robinhood Roofing shirt and hat on. I contacted Robinhood roofing in an attempt to gather information to obtain a job site location for Kerr. The Robinhood Roofing employee advised that she fired Kerr this morning via text because he did not show up to work last week. Esterburg was called back, and was able to provide a next of kin name. I contacted Kerr's sister Meghann Preseren over the phone to attempt to gather more information. Preseren stated that Kerr has always struggled with depression, and that law enforcement "triggered" him. Preseren reported that she believed Kerr might attempt "suicide by cop". Preseren said she was contacted by Brimfield PD in reference to Kerr on 06/23/2025. During the call for service, Brimfield PD noticed a firearms case in Kerr's vehicle, but advised he would not speak with an officer. No additional contact was made by Brimfield PD per dispatcher Clark. Dispatch was advised to enter Kerr into NCIC with a caution to law enforcement. Shortly after entering Kerr, Parma Heights Police Department advised Kerr was involved in a pursuit that ended in a crash. It was reported later that a Kerr was involved in a stand off with Parma Heights Police Department. Kerr was later reported deceased. Copy of Esterburg's text messages attached with report and forwarded to Parma Heights PD.

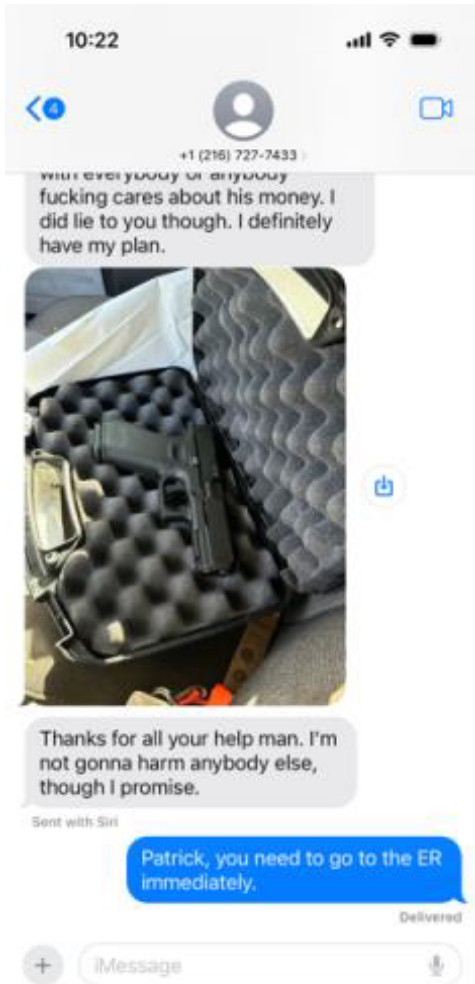

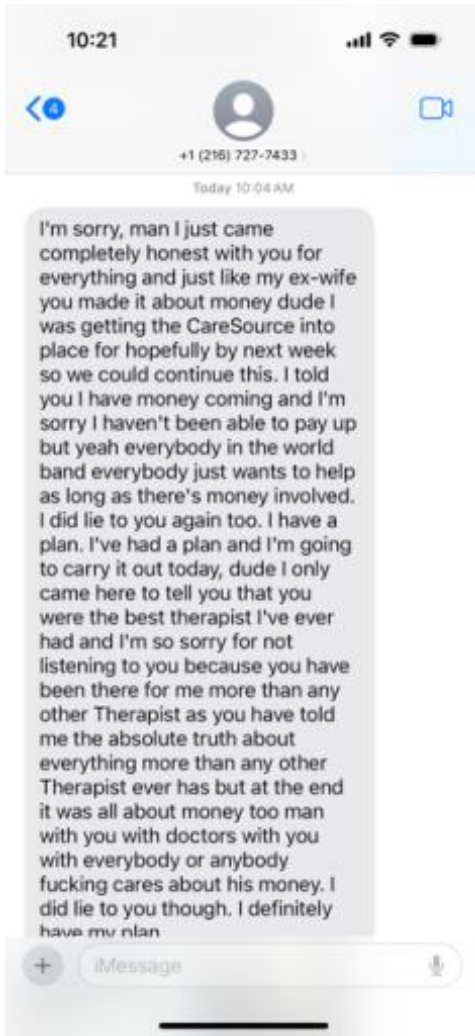

Synopsis

Narrative by Officer Shamus Kelley #7176

On this listed date and time, I responded with Officer Kadlec to the Kings Inn Motel room #154 for report of a welfare check. Initial reports from the caller, listed arrested adult Patrick Kerr, was that his ex-girlfriend texted him and told him that she was going to kill herself by taking pills.

We traveled to the room and spoke with the listed subject, who informed us that she had no intentions of harming herself, and further stated that she knew we were coming because Kerr stated that he was going to do so because she would not open the door to her room so they could get drunk together.

The listed subject showed Kadlec and I the text message transcripts between she and Kerr that indicated that the two were planning on drinking alcohol together in the motel room but the subject changed her mind, claiming that she wanted to stay sober and go to rehab the following day. She stated in this text message that she wanted Kerr to leave her alone. Kerr stated in response that he was going to call the police and tell SPD that she was trying to kill herself because she would not open the door.

After looking into this matter, interviewing Kerr over the phone, and obtaining copies of the text message transcripts I determined probable cause existed to arrest Kerr for Falsification. Kerr came to the SPD lobby with a friend and was subsequently taken into custody and charged into Mayor's Court for Falsification. Bond was set and he is to appear on 5/30/13.

The text message conversation was photographed and downloaded into the photo log. They are also included in this report.
