APPROVAL—GRANTS OF EASEMENT, STATE OF OHIO, THROUGH CONSERVATION COMMISSIONER, THREE GRANTORS, NUMBERED AND DESIGNATED, TRACTS OF LAND, JEFFERSON AND WAYNE TOWNSHIPS, FAYETTE COUNTY, OHIO, FOR PUBLIC FISHING GROUNDS AND TO IMPROVE THE WATERS OR WATER COURSES PASSING THROUGH AND OVER SAID LANDS.

DEAR SIR: You have submitted for my examination and approval certain grants of easement executed to the State of Ohio by several property owners in Jefferson and Wayne Townships, Fayette County, Ohio, conveying to the State of Ohio, for the purposes therein stated, certain tracts of land in said townships and county.
