Narrative:

On Wednesday, August 23, 2023, the Ohio Bureau of Criminal Investigation (BCI) was requested by Chief Nick Roberts of the Howland Township Police Department (HTPD) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved shooting which occurred at Howland Township, Trumbull County, Ohio. BCI Special Investigations Unit (SIU) Special Agent (SA) Cory Momchilov responded to assist. Special Agent Supervisor (SAS) Jon Lieber, SA Joseph Goudy, and SA Andy Harasimchuk also responded from the Special Investigations Unit as well as Special Agent Bill Conn of the BCI Cyber Crimes. Additionally, the BCI Crime Scene Unit was requested to process the scene by documenting and collecting pertinent evidence.

The shooting incident involved a subject, Randall Fife (Fife), and three members of the Mahoning Valley Regional SWAT Team. The incident resulted in the injury of Fife. He was eventually transported to St. Elizabeth's Hospital in Youngstown for additional life saving measures. It was later learned that Fife died on Monday, August 28, 2023 while admitted to the hospital.
